#### One Hundred Seventeenth Congress of the United States of America

#### AT THE FIRST SESSION

Begun and held at the City of Washington on Sunday, the third day of January, two thousand and twenty-one

#### An Act

To provide for reconciliation pursuant to title II of S. Con. Res. 5.

Be it enacted by the Senate and House of Representatives of the United States of America in Congress assembled,

#### SECTION 1. SHORT TITLE.

This Act may be cited as the "American Rescue Plan Act of 2021".

# **Employee Retention Tax Credit**

**Increases credit from 50% to 70%** 

Per Quarter vs. Per Year

Lowers Eligibility Threshold to Employers Experiencing a 20% Loss in Receipts

**Raises Employee Cap to 500 or Fewer** 

Can Receive a PPP and Employee Retention Tax Credit

American Rescue Plan Updates – Extends to Dec. 31, 2021 Start-ups Established After February 15, 2020 Are Now Eligible



### **Shuttered Venue Operators Grant**

#### \$15 Billion Grant Program

Eligibility:At least a 25% drop in gross revenueEligible Entities:Live venue operators or promoters<br/>Theatrical Producers<br/>Live Performing Arts Organization Operators<br/>Museum Operators, Zoos, & Aquariums<br/>Motion Picture Theater Operators<br/>Talent Representatives

Grant Amount: 45% of 2019 gross revenue up to \$10 million

### **Restaurant Revitalization Fund**

**\$25 billion Grant Program Eligible Entities: Primary Purpose is to Serve Food & Beverage** Grant Amount: Pandemic-Related Revenue Loss (\$10 million/entity, **\$5 million/location) Grant Uses:** Payroll Mortgage & Rent Utilities **Supplies Food & Beverage Expenses Paid Sick Leave Operational Expenses** 



## **Paycheck Protection Program**

**Re-opened & Extended Through 3/31/21 Second Draw for Hard Hit Businesses Simplified Forgiveness for Small Loans Expands List of Eligible Expenses** Forgiveness and Deductibility of Expenses NOT Taxable **EIDL Grant No Longer Reduces Forgiveness** 501(c)(6) Non-Profits (Chambers of Commerce) American Rescue Plan Updates – **Expanded Eligibility for Non-Profits** Additional Funding

### GUIDE TO PPP LOAN FORGIVENESS

Under the Paycheck Protection Program (PPP) created by the CARES Act, loans may be forgiven if borrowers use the proceeds to maintain their payrolls and pay other specified expenses.



The Treasury Department and Small Business Administration recently released the application form and instructions for loan forgiveness. The forgiveness forms, instructions, and worksheets can be downloaded <u>here</u>.

PPP borrowers must apply for loan forgiveness with the lender that processed the loan. This guide is designed to help borrowers understand the process by which their loan forgiveness amount will be calculated and the overall approach of the loan forgiveness process.
