Dear CAPCSD Members,

I hope this letter finds you all well. It's that time of year when so many things are happening in our programs. I want to take this opportunity to highlight some of the "going ons" with CAPCSD and the ways we can support your programs.

CSDCAS Admissions: For many programs, this finds you in the thick of your admissions process. So far this year, over 12,500 applicants have submitted over 43,000 applications through CSDCAS. We have seen a 4% average increase in SLP applications per program and an 8% average increase in AuD applications per program, when compared to this time last year. While we are not back to the level of applications per program that we saw two years ago, we are glad to be on an upward trend. The CSDCAS community has grown to include over 70% of CSD graduate programs. If you are interested in learning more, please join us for the *Got CSDCAS? Sessions cover topics like facilitating holistic admissions in graduate programs, how AuD clinical faculty integrated virtual clinical training during a pandemic, budget basics, personal wellness in preventing burn-out, and the relationship between student perceptions of their cultural identity and perceived abilities to meet essential

functions. Join us for Friday's plenary session *A Framework for Diversity, Equity, and Inclusion* presented by CAPCSD's newly formed DEI Task force in response to the nationwide cries against racial injustice.
