### **Essential Functions Task Force**

The CAPCSD Board of Directors approved the creation of a task force charged with overseeing review and revision of its documents regarding essential functions for audiology and speech-language pathology students. These materials were developed by CAPCSD in 2008, and the board recognizes that they do not reflect current best practices and pose potential biases, particularly in ways that may negatively impact accessibility to the professions of audiology and speech-language pathology by members of BIPOC,

culturally and linguistically diverse, and disability communities. This task force is charged with: reviewing the current literature regarding the development, use, and potential misuse of technical standards/essential functions; examining existing CAPCSD essential function documents; and proposing changes based on best available information. Suggestions for revisions will be presented for Board approval and provided as a resource for CAPCSD member programs when finalized.

### **Admissions – April 15<sup>th</sup> Deadline**

Once January comes to an end, most of us are in full swing with the process of reviewing applications for admission to our programs for the 2022 – 2023 academic year. You'll receive an email reminder from me in the upcoming weeks regarding adherence to the national **April 15<sup>th</sup> deadline** for student acceptance of admission and financial aid offers. CAPCSD appreciates that member programs are mindful of this resolution.

### **Scholarship Program**
