Hometown Dollars Rules & Regulations

The Grove City Area Chamber of Commerce is offering Hometown Dollars Gift Certificates redeemable at participating area businesses. (Grove City Area Chamber of Commerce may also be referred to as “The Chamber”, “Chamber of Commerce” or “GCACC”) The Hometown Dollars Gift Certificate program will function as described below. **These policies replace and supersede any and all previous HomeTown Dollars Gift Certificate Program information. Please read carefully.**

- Standard Certificate amounts will be sold in denominations of \$25 only. Purchasers will be limited to (2) two gift certificates per household.
- Beer, alcohol, and tobacco products may not be purchased with Hometown Dollars Gift Certificates.
- Participating businesses will forward their redeemed certificates to the Grove City Area Chamber of Chamber office weekly along with a request for reimbursement form and will be reimbursed for the full face value.
- Certificates will have no cash value and no change will be given upon redemption.
- The agreement with the participating businesses to redeem certificates will remain active until the business notifies the GCACC in writing of their desire to drop from the program
- Hometown Dollars Gift Certificates will be available at the Chamber office at 4069 Broadway, Grove City, OH 43123 and on the GCACC website www.gcchamber.org
- Hometown Dollars Gift Certificates are only valid at the location named on the certificate and cannot be redeemed at other businesses.
- A list of current participating businesses will be available on the Chamber Website
- In compliance with Ohio’s Gift Card/ Certificate rules, certificates will be good for 2 years from the date of purchase. The expiration date will be listed on each certificate.
- For a list of complete business eligibility rules please look at City Ordinance C-15-21

Reimbursement For Redeemed Hometown Dollars Gift Certificates

- Gift certificates will be embossed and will display the business logo and the \$25.00 denomination value. Any certificates that were not verified or are missing security features may not be eligible to receive reimbursement.
- Requests for reimbursement must be accompanied by an official GCACC reimbursement form and the physical redeemed certificates.

Purchasing Hometown Dollars Gift Certificates

- The Hometown Dollars Gift Certificate Program limits purchases to \$50.00 per household.
- Gift Certificates have no cash value and must be spent in their entirety, as no cash will be given back for any amount not used.
- Payments may be made in Cash, Credit Card, or Check either at the GCACC office or at GCChamber.org
- Gift certificates will not be printed until full payment is made.
- Purchaser has 30 days from order date to complete payment or order will be canceled
- Gift certificates will not expire for 2 years from the date of purchase

- Be in compliance with of Grove City Ordinance C-15-21
- Be a member in good standing with the GCACC
- Provide the following to the GCACC (heather@gcchamber.org)
 - Signed agreement
 - Business logo in the format requested (300dpi)
- Agree to accept Gift Certificates for payment in exchange for merchandise or service
- Promote the program via your social media and other outlets.
- Media toolkit will be provided by the GCACC marketing team.

Please note that merchants are not able to purchase Gift Certificates for their own business.
