#### I UNDERSTAND:

- $\checkmark$  Food booth/truck application fee is non-refundable. (Must be paid in Full.)
- ✓ Food booth/truck vendors are required to participate on Saturday until 10:00pm
- I cannot sell any type of beverage at my booth.
- I will provide a certificate of insurance with the Weslaco Chamber of Commerce and the City of Weslaco named as co-insured. (If available, understanding that the Weslaco Chamber and City of Weslaco are not liable for any accidents)
- $\checkmark$  I will provide a photocopy of my driver's license.
- ✓ The Texas Onion Fest Committee reserves the right to prohibit at the time of entry or the time of the festival any material or presentation found offensive or illegal.
- ✓ The Texas Onion Fest Committee will <u>not</u> furnish electrical extension cords or multiple electrical outlet strips (surge suppressors, etc.). Only 10 to 12-gauge extension cords will be accepted.
- ✓ Vendors shall have at least a 5 lb. ABC fire extinguisher with current tag, or show proof of purchase, in booth close to the exit away from stove. Minimize the use of too many extension cords within booth. Fire Marshall will be on site Saturday morning to inspect each booth/truck for compliance with city ordinance.
- $\checkmark$  I may not resell or sublet my booth to another vendor.
- ✓ Food booth/truck location will not be reserved unless payment has been received.
- ✓ All food booth/trucks must remain open during Onion Fest hours, on Saturday 10AM to 10PM
- ✓ Booth/truck vendors agree to hold Onion Fest and its agents harmless from any and all liability whatsoever.
- $\checkmark$  I understand guidelines are subject to change.
- I authorize the Chamber and Onion Fest to use photographs of my booth/truck during the event. I understand that these photographs will be utilized for promotional, recruitment, and informational purposes.
