





## STATE OF THE LANSING REGION BENCHMARKING REPORT

In 2019, the Lansing Regional Chamber of Commerce and Lansing Economic Area Partnership (LEAP) partnered with 10 leading business and education stakeholders and commissioned Anderson Economic Group to develop the first State of the Lansing Region Benchmarking Report.

In May 2021, the report was officially released to the local business community. It showcased the region's core strengths and growth opportunities by comparing the region against 11 thriving communities in the nation on 42 economic indicators. It also showcased the need to establish a vision for the Lansing region's future and move the needle on population growth, educational attainment, private sector investment, job growth and affordability.

In October 2021, a statewide business coalition consisting of chambers of commerce and business-related associations, was formed in response to Biden vaccine mandate for employers with over 100 employees. The Listen to MI Businesses coalition advocated that top-down government mandates limit employer and employee rights and would have a devastating impact on Michigan jobs, communities and economy.






## ACCE Chamber Innovation Summit


