The Bleeding and Clotting Disorders Institute, Serving Patients in Illinois for 10 Years!

Dr. Michael Tarantino, Chief Medical Officer and CEO of the Bleeding and Clotting Disorders Institute (BCDI) opened BCDI ten years ago this April! BCDI's mission is to provide integrated, family-oriented care, treatment and education for persons with bleeding, blood clotting and other blood disorders.

BCDI is the only non-profit federally funded Hemophilia Treatment Center of Excellence in Illinois outside of Chicago drawing patients from throughout the state via physician, hospital and selfreferrals.

The team at BCDI uses a comprehensive care approach, employing a diverse team of professionals to treat all aspects

of the patient's disorder. This team includes a hematologist, nurse practitioner, nurse coordinator, social worker, physical therapist, dentist and nutritionist or immunologist where appropriate. The members of this team meet with the patient and determine a care plan that is shared with other care providers, as well as the patient and their family. This year alone we will hold over 65 comprehensive clinics throughout the state.

BCDI held the first Immune Thrombocytopenia Purpura (ITP) comprehensive clinic in the United States in 2017. If this model helps patients with other bleeding and clotting disorders, Dr. Tarantino felt it was important to offer it to ITP patients. To date, this clinic

has served over 67 patients.

Education is critical to our patients and families. In 2019 alone, we took part in over 110 educational opportunities to spread the word about bleeding and clotting disorders, signs and symptoms and how care at a hemophilia treatment center can benefit these patients.

Research was a key component of BCDI from the beginning. When asked why BCDI focuses on research, Dr. Tarantino said, "We want to be part of developing the cutting-edge treatments for our patients, not hearing about them". In the last ten years our doctors have been involved in 63 research studies and written and published over 100 articles.

GOVERNMENT AFFAIRS

A \$2.2 trillion stimulus bill - The Coronavirus Aid, Relief, and Economic Security (CARES) Act, the largest economic relief bill in U.S. history, builds on H.R. 6201, the Families First Coronavirus Response Act (FFCRA), in support to individuals and businesses affected by the pandemic and economic downturn. These funds are to be used to provide economic relief and options amidst the growing COVID-19 pandemic.

Key Points:

• Provides nearly \$350 billion in federally guaranteed loans via the Paycheck Protection Program to provide eight weeks of cash-flow assistance to small businesses who maintain their payroll during this emergency. If employers maintain their payroll, the loans would be forgiven, which would help workers to remain employed and affected small businesses and our economy to quickly snap-back after the crisis.

• Allows the Paycheck Protection Program to cover payroll costs, paid sick leave, supply chain disruptions, employee salaries, health insurance premiums, mortgage payments, and other debt obligations to provide immediate access to capital for small businesses impacted by the coronavirus.

• Provides \$17 billion in small business debt relief by requiring the Small Business Administration to pay all principal, interest, and fees on all existing SBA loan products for six months to provide relief to small businesses negatively affected by the coronavirus.

• Provides \$10 billion for expanded eligibility for SBA Economic Injury Disaster Loans, including emergency grants, an advance of \$10,000 within three days to maintain payroll, provide paid sick leave, and to service other debt obligations.

Paycheck Protection Program (PPP) vs. Economic Injury Disaster Loan (EIDL):

PPP- Low-interest loans (capped at 4%) to pay Payroll Costs for the eight-week period after the PPP is originated. Covered Period: February 15, 2020 – June 30, 2020. Eligibility: Any business in operation before February 15, 2020, that (1) has fewer than 500 employees or (2) otherwise meets the SBA's existing Size Standard (predicated or NAICS code and annual revenue). Recipients of SBA Disaster Loans made after January 31, 2020, may receive a PPP loan for purposes other than what was borrowed under the SBA Disaster Loan (no "double dipping"). Nonprofits, independent contractors and self-employed gualify.

EIDL-Low-interest loans (capped at 3.75%) for working capital to small businesses suffering substantial economic injury due to COVID-19. Borrowers can request \$10,000 payable three days after application. If the EIDL loan is denied, the advanced funds do not need to be returned. Covered Period: January 31, 2020 – December 31, 2020. Eligibility: Any small business or private nonprofit organization that meets SBA's Size Standard (predicated or NAICS code and annual revenue) that has suffered Substantial Economic Injury due to COVID-19. A business has suffered "substantial economic injury" when it is unable to meet its financial obligations, pay ordinary and necessary operating expenses or has a reduction in working capital. Businesses are ineligible that have not complied with a previous SBA loan.
