

MEMBER FEATURE OSF HEALTHCARE

Redesigning Digital Health Care

The COVID-19 pandemic provided OSF HealthCare the opportunity to digitally transform health care guickly.

Michelle Conger, OSF chief strategy officer and chief executive officer of OSF OnCall, said simulation technology, advanced analytics and a ventures arm, allowed OSF to redesign its digital care.

The vision was steadfast: Digital health is to serve people how and where they are and not designed around the preferences of a health system. The goal was to create a digital hub from which OSF could scale digital care across the communities it serves. This month, OSF will move its physical digital hub headquarters to a renovated building in downtown Peoria.

Conger had been building a digital infrastructure for nearly seven years. Then the pandemic hit, providing OSF the real-life testing ground for reimagining a patient's journey using digital technology.

It began with Clare, an artificial intelligence chatbot that digitally triages symptoms and hands off potential COVID-19 patients to a nurse hotline or the COVID Companion, a free texting program OSF developed that offers tips, resources and a symptom checker. Other key components of the OSF HealthCare digital response include:

- SilverCloud, a free, secure interactive digital platform to help manage stress, anxiety or depression available at osfhealthcare. org/silvercloud
- 24/7 Nurse Hotline for COVID-19 response
- 24/7 provider video visits
- Pandemic Health Worker program, in contract with the state of Illinois, helps slow the rate of new infections by allowing patients



to isolate safely at home

- Digital Hospital at Home for lower-acuity non-COVID patients who can transition from the hospital to home
- ConstantCare and eHospitalists for individuals with COVID-19 symptoms that need hospitalization
- Acute COVID@Home for patients at risk for hospitalization

What's resulted is a digital platform for the future. OSF is expanding its master brand with the new hybrid brand, OSF OnCall, linking the new brand with modern, convenient digital and in-person services.

"We want a platform that enables outreach to populations lacking access to care and wellness, and digital technology helps us achieve that," Conger said. "Because it's digital, we're able to customize the relationship. Health care can be hard to use. It's difficult to make something really easy. That's why this continues to be a work in progress."

GOVERNMENT AFFAIRS Laws that go into effect Jan. 1, 2021

As we enter the New Year, we celebrate and look forward. Some of what we get to look forward to usually includes the introduction of new laws determined in the previous year. These new laws go into effect January 1, 2021 in Illinois. While laws have the potential to be introduced and passed at various points throughout the year, we often see some of the most significant changes arrive with the New Year.

This coming year, we will see changes regarding an increase to the minimum wage, a potential statewide tax increase, changes to how employers have to report instances of sexual harassment and discrimination to the Illinois Department of Human Rights, and the introduction of a college fund for children born and adopted in our state.

Minimum Wage Increase

- For the third time since 2010, minimum wage workers in Illinois are getting a raise. A previous increase occurred on January 1 and July 1, 2020. Under the new law, the minimum wage will increase to \$11 per hour on January 1, 2021. That amount will continue to expand on an annual basis until it reaches \$15 per hour on January 1, 2025.
- Prior to the first 2020 increase, the last time Illinois increased its minimum wage was in 2010 when it went from \$8 to \$8.25 per hour. In response to the rise, Michael Kleinik, director of the Illinois Department of Labor, said, "While IDOL fully expects employers to abide by the new minimum wage, it is important for workers to inspect their checks to make sure they reflect the increase."

Potential Tax Increase

In the November 2020 election, voters were asked whether to approve a constitutional amendment that would shift the state from a flat to a graduated income tax. At the time, Illinois Lt. Gov. Juliana Stratton warned that if voters did not approve the constitutional amendment, all residents could see an income tax hike of at least 20%.

• Voters did not pass the amendment. According to Stratton, "To adequately address the budget crisis under our current tax system, lawmakers will be forced to consider raising income taxes on all Illinois residents by at least 20% regardless of their level of income." A 20 percent increase would bring Illinois' current income tax rate up from 4.95% to 5.94% across the board.

Employers and Discrimination Claims

On July 1, 2020, an amendment to the Illinois Human Rights Act reduced the number of employees that an employer must have to be subject to state discrimination laws from 15 to 1. To continue increasing employee protections, employers will be required to file any final, adverse judgments or administrative rulings enter against them in discrimination or sexual harassment to the Illinois Department of Human Rights. Employers will have to file these reports for the preceding calendar year before July 1 of each subsequent year.

College Fund for Children in Illinois

- · Beginning January 1, every child born or adopted in Illinois will get \$50 deposited in their college savings account or 529 plan. That deposit is part of a new law, which introduces the Illinois Higher Education Program. Financial experts say the cost to attend college keeps going up five to six percent every year, so state legislators hope this law will combat those rising college tuition prices. Lawmakers hope it will also remind parents to contribute to their child's college fund starting at birth.
- To start the program, it will cost Illinois \$8 million and another \$1.5 million each year thereafter. Over the course of 18 years, that \$50 with dividends and interest will grow maybe a few hundred dollars, but the program's goal is to help families and give parents a place to save. Research shows that a child is more likely to attend college just by having a savings account in place.
- High school graduates who do not use the money by the time they are 26 will have to forfeit the \$50 back to the state for other students in the future.

ANEREN NEWS LED Lights Steal the Show at Peoria Civic Center

From country crooner Blake Shelton to local talent like the Peoria Rivermen Hockey Club, the Peoria Civic Center offers an array of world-class entertainment. Lighting helps create a mood to match every performance.


In the mood to reduce the facility's energy costs, civic center management put two major LED lighting projects center stage. The Ameren Illinois Energy Efficiency Program provided more than \$152,000 in cash incentives that covered more than half of the city's project costs.

"Ameren Illinois offers incentives for a lot of things I wasn't aware of," says Will Kenney, Director of Operations at the civic center. "The application process was easy and the transition [to new lighting] was smooth."

Working with Ameren Illinois Energy Advisors and Oberlander Electric Company, Kenney first targeted the 11,330-seat Carver Arena, replacing a mix of metal halide and incandescent lighting that dated back about 20 years. Next, LED lighting was installed in more than 110,000 square feet of exhibit space.

As a result, the Peoria Civic Center reduced its annual energy costs by an estimated \$67,000 and created a safer, more appealing environment for patrons. New LED lighting controls allow staff to easily adjust lighting levels to accommodate different events.

"Along with a decrease in utility costs, the light quality is definitely better than before. We've received a lot of positive feedback," says Kenney. "I highly recommend the Ameren Illinois



Energy Efficiency Program. The Ameren Illinois team made it very easy to follow through."
