GOVERNMENT AFFAIRS

News:

In Illinois, many new laws take effect in 2023.

Business & Work:

The annual increases in the state's minimum wage continue, and on Jan. 1, 2023, the minimum wage for most workers increased to \$13 per hour. The minimum wage for those who receive tips for their work (i.e., restaurant servers) will raise to \$7.80 per hour, and the wage for those younger than the age of 18 who work fewer than 650 hours per year will increase to \$10.50 per hour. Annual increases continue until Jan. 1, 2025, when the minimum wage hits \$15 per hour.

SB 1698 Increases the taxable wage base by 2.4% annually beginning in 2023 until 2027 and targeted Unemployment Insurance Trust Fund solvency balance from \$1 billion to \$1.75 billion. Establishes terms for a \$450 million interest-free loan to the UI Trust Fund from the State Treasury.

SB 2984 Adds youth entrepreneurs to the list of individuals eligible for training and mentorship programs offered by entrepreneurship assistance centers.

SB 3120 The Family Bereavement Leave Act (FBLA) gives eligible employees the option of unpaid time off for certain situations. It allows time to grieve the death of a family member covered by the act. It also covers time off for certain pregnancy events, like miscarriage, or other diagnosis that impacts pregnancy. Lastly, it covers adoption related events. Eligible employees will be allowed to use a maximum of two weeks of unpaid bereavement leave.

SB 3127 Formally recognizes emergency medical dispatchers as first responders.

SB 3416 The One Day of Rest Act includes two important changes. First, employees must get one day of rest in "every consecutive seven-day period." And second, employees must get a 20-minute meal break for the first 7.5 hours worked. After that they must get another 20-minute break for each additional 4.5-hour period worked after.

SB 3616 CROWN (Create a Respectful and Open Workplace for Natural Hair) Act The CROWN Act creates protections for Illinoisans discriminated against due to hairstyles historically associated with specific racial groups.

SB 3930 Expands the Illinois Home Grown Business Opportunity Act to include notices of funding opportunities to small businesses and municipalities along the border of Illinois. Requires the Illinois Department of Commerce and Economic Opportunity to notify small businesses and municipalities

of new COVID-19 restrictions.

SB 3938 Removes the requirement for the Illinois Department of Innovation and Technology to assist client agencies in identifying funding opportunities and ensuring compliance with all applicable laws, regulations, and grant terms.

HB 5225 Requires the Illinois Department of Commerce and Economic Opportunity to develop a program to award grants to organizations to distribute subsidies to individuals participating in an apprenticeship program, pre-apprenticeship program, or work-based learning program.

HB 5576 Provides that the state shall not regulate professions, occupations, industries, businesses, or trades in a way that adversely affects a competitive market of equitable access to job and economic opportunities.

School & Higher Education:

SB 3902 Students entering high school in the '23-'24 school year need to complete at least one year of computer science. This is a new graduation requirement. Additionally, all public high school students must complete the Free Application for Federal Student Aid (FAFSA) form. If they do not want to file it, they must waive it. This is a requirement in order to receive their high school diploma.

SB 3925 Creates the Human Service Professional Loan Repayment Program to recruit and retain qualified direct service professionals to work for community-based human service providers by providing loan repayment assistance to eligible direct service professionals.

SB 3972 Creates a program to provide high school students with experience relating to work in the intellectual and developmental disabilities field.

SB 4028 Creates a mental health council that works to figure out how to help children in school to find a mental health provider and how to access the mental health system. Puts into school curriculum lessons and teachings about mental health.

HB 3296 Requires school boards to establish a career and technical education pathway program for grades 6 through 12.

HB 4201 Requires each public university and community college's Board of Trustees to designate a benefits navigator who can assist students with benefit eligibility and how to apply.

HB 4343 Schools can establish wellness checks for students in the 7th grade through 12th grade. The Department of Healthcare and Family Services can also do this. The purpose of these wellness checks is to

identify and help students who are at risk of mental health conditions. Some examples of these conditions including depression or anxiety.

HB 4798 Addresses the shortage of substitute teachers throughout the state by allowing students enrolled in approved teacher training programs who have earned at least 90 credit hours to obtain a substitute teaching license.

HB 5265 Requires school districts to waive all school fees for students experiencing homelessness.

HB 5488 Middle school and high school students will be allowed to miss one day of school per year to attend a civic event.

HB 5506 Allows partnership agreements between Community College districts and School districts to allow high school students to enroll in a dual credit course for high school credit and collect demographic data.

Health & Benefits:

Several bills were passed and signed into law that expand insurance coverage for specific screenings and health conditions. Beginning in the New Year, insurance companies must provide coverage for:

- Prenatal vitamins when they are prescribed by a physician,
- Prostate cancer screenings with no copay required,
- Medically necessary Continuous Glucose Monitors for those diagnosed with Type I or Type II diabetes, and
- Genetic testing to detect an increased risk for breast and ovarian cancer if the tests are recommended by a health care provider.
- Additionally, "home health services" must now be covered for the duration of medically necessary care.

SB 3166 Requires hospitals, establishments, or facilities to ensure nurses are aware of the Illinois Professionals Health Program and also requires one hour of continuing education training on substance abuse and disorders.

HB 2382 Expands access to healthy foods in eligible areas throughout Illinois by providing assistance to grocery stores, corner stores, farmers markets and other small food retailers.

HB 2595 Access to mental healthcare Illinois insurance must cover medically necessary mental health care. This includes treatment for mental, emotional, nervous or substance use disorders.

HB 4645 Creates an Equity and Representation in Health Care Workforce Repayment Program to provide loan

repayments and scholarships for health care professionals who serve in Illinois medical facilities for a specified period of time. Prioritizes increasing diversity in medically underserved areas.

Money & Debt:

HB 2775 Aims to make it easier for low-income families to find housing by declaring that it is a civil rights violation for any person engaging in real estate transactions to discriminate based on source of income.

HB 4410 Creates the Real Estate Valuation Task Force to help resolve the history of discrimination in the housing industry.

HB 4682 Veterans emergency financial assistance Veterans' Cash grants for emergency financial assistance can be used to pay for past due utilities, housing, and transportation costs.

Vehicles:

SB 3609 Allows drivers to apply for a one-time \$25 rebate, "if the vehicle is manufactured in this state and the application for title is made no more than one year after the month in which the vehicle was manufactured."

HB 3772 This law ensures people whose cars have been stolen will not be liable for violations, fees, fines or penalties when their vehicles are caught on red light or speed cameras.

HB 5304 Reduces the vehicle registration fee for senior citizens from \$24 to \$10.

Motor Fuel Tax: The same year Gov. Pritzker signed the minimum wage bill, he also signed a multi-year, \$45 billion transportation and capital improvements bill known as "Rebuild Illinois," which is funded in part with higher motor fuel taxes that are scheduled to increase with inflation each year. As a result, Jan. 1, the motor fuel tax people pay at the pump went up 3.1 cents per gallon, and it will increase again when the next regular adjustment date comes around on July 1, 2023.

Advanced Innergy now has its Hyperbaric Room installed. Sit back and relax as you enjoy the latest in oxygen therapy. This is a low pressure, ambient air hyperbaric chamber.

The American Water Charitable Foundation awarded a \$5,000 grant for a Peoria art project. Artists ReEnvisioning Tomorrow (ART) Inc. will repurpose 10 retired fire hydrants donated by Illinois American Water to create art. Young student artists of various ages and skill will paint the hydrants while also learning about fire protection and water service. A key partner in this project is the Peoria Fire Department, which will help provide programming and auction off the hydrants to donors to raise additional funding for ART Inc.

Rebekah Bourland is the 2022 recipient of the ArtsPartners of the Year Award from **ArtsPartners of Central Illinois, Inc.** The award recognizes exemplary support of and service to the arts in central Illinois. ArtsPartners also presented the Arts Legacy Award to two honorees: the **Peoria Symphony Orchestra** in recognition of its 125th season, and the **Carver Center** in recognition of its 100th anniversary.

Libby Derry has been named executive director of communications and media relations at **Bradley University**. She most recently served as media relations coordinator for **OSF HealthCare**. Prior to that, she was a television journalist in multiple markets, including in Peoria at **WEEK-TV**.

Seeking to expand its autonomous fleet beyond mining, Caterpillar Inc. will collaborate with Luck Stone, the nation's largest family-owned-and-operated producer of crushed stone, sand and gravel.

A \$35 million Extraordinary Dividend was approved by CEFCU's Board of Directors and distributed to the Credit Union's member/owners. The amount each member received was determined by dividends earned and interest paid during the first 11 months of the year. On December 1, funds were deposited to members' Savings accounts. Over the last 22 years, CEFCU has returned \$415 million in Extraordinary Dividends to members.

The Center for Prevention of Abuse (CFPA) has been awarded a \$53,400 Safe Housing grant from RedRover to create a program designated to safely care for the pets of domestic violence survivors. CFPA is the only grant recipient in Illinois. With this grant CFPA created the Pet Peace program to help clients residing in its domestic violence shelters with the boarding, feeding, medical care and vaccination of their dogs and cats.

Central States Media has changed its name to **Central States Marketing**. Since its formation, Central States Marketing has grown from three to 25 employees and has offices in three states. Though its midwestern roots run deep, CSM serves national and international clients, running campaigns in five languages in 10 countries. The company is at 2006 W. Altorfer Drive, Peoria.

The City of Peoria has distributed \$1.4M to 118 area businesses negatively impacted by the COVID-19 pandemic. With funds from the American Rescue Plan Act, the city's Economic Development Department launched the RISE (Recovery, Income, Startup, Expansion) program in May 2022. Of the businesses that received funding, 82% are minority-owned, woman-owned, minority-and-women-of-color-owned, and/or veteran-owned.

CityLink's 35th Annual Stuff-A-Bus food drive, created to help eliminate hunger in Peoria, benefitted the Peoria Friendship House of Christian Service and officially wrapped up donations in November 2022. The campaign began in October and concluded with a press conference at the Peoria Friendship House of Christian Service. The total weight of donations collected during this year's Stuff-A-Bus food drive totaled 24,942 pounds or 12.47 tons. This is a record collection for the Stuff-A-Bus food drive. The previous record was recorded in 2008 with 11.8 tons collected.

The Community Foundation of Central Illinois (CFCI) has welcomed Andrea Ingwersen as the new Director of Communications and recently awarded over \$290,000 through the Community Needs, Local Jobs Fund, and Women's Fund Success grants to local nonprofit organizations providing vital programs and services to the central Illinois community. Organizations funded include: Goodwill Industries of Central Illinois, EP!C, Hult Center for Healthy Living, Dream Center Peoria, Heart of Illinois Big Brothers Big Sisters, Adult & Teen Challenge of the Greater Midwest, Center for Prevention of Abuse, Freedom House, ART Inc., Loving Bottoms Diaper Bank, Public Interest Law Initiative, LifeLine Pilots, Neighborhood House, Tazewell County Health Department, The Autism Collective, Peoria Friendship House, George Washington Carver Association, Minority Business Development Center, Prairie State Legal Services, FamilyCore, Peoria Public Schools Foundation, Easterseals Central Illinois, Camp Big Sky, Phoenix **Community Development Services, Girl Scouts of Central** Illinois, Girls on the Run of Central Illinois, The Christian Center, HVCDC/Jobs Partnership, and Crittenton Centers.

Mike Tchang has joined **Cullinan Properties** as senior vice president, director of real estate. Eureka College has received \$1.25 million lead gift for a \$2.5 million project that will create a new Student Success Center and modernize the college library. Inside Melick Library, the 27,000-square-foot center will house all student life and academic support services. Library resources also will be updated. The project is part of a larger initiative to strengthen the school's First-Generation program and other retention-oriented programs and services. The donor, who wishes to remain anonymous, was a first-generation college student. This fall, 54% of Eureka's 279 first-year and transfer students were first-generation students. The construction and renovations are planned to begin in spring 2023.

On Jan. 4, **Heartland Health Services** – Sheridan relocated adult care, counseling services and medication-assisted treatment services to the **Human Services Center**. HSC

is located at 228 NE Jefferson St., Peoria. Heartland Health Services – Sheridan is currently located in the Peoria City County Health Department Building at 2116 N. Sheridan Road, Peoria, which is undergoing renovations. The clinic will move back to 2116 N. Sheridan Road when construction is complete in 2024.

Rebecca Losli has been named president of **Illinois American Water**. She joined American Water in 2021 as director of engineering for Missouri American Water. Kyle Smith has been named the senior operations manager for the company's Western Division. He will oversee operations in the Peoria, Pekin and Lincoln Districts.

Midwest Food Bank Peoria, IL, has hired Audrey Kamm as the new Executive Director. Audrey will assume the role effective February 1, 2023. She most recently served as the Vice President of Operations for the Peoria Area Chamber of Commerce. As Executive Director, Audrey will be responsible for ensuring MFB programs are executed with efficient use of facilities, employees, and volunteers. She will also manage budgeting, fundraising, community engagement, and other requirements for not-for-profit operations.

Lucas D. Myrna is the new executive manager of the Central Illinois Chapter of the National Electrical Contractor's Association's (NECA), where he will advocate for and spread awareness of the electrical construction industry in central Illinois.

OSF HealthCare Saint Francis Medical Center in Peoria has earned a distinguished three-star rating from The Society of Thoracic Surgeons (STS) for its patient care and outcomes in isolated coronary artery bypass grafting procedures. The STS star rating is calculated using a combination of quality measures for specific procedures performed by an STS Adult Cardiac Surgery Database participant. The three-star rating, which denotes the highest category of quality, places OSF Saint Francis among the elite for heart bypass surgery in the United States and Canada.

The Economic Impact of the 2022 Peoria Art Guild Fine Art Fair was \$300,420 according to calculations by the Peoria Conventions and Visitors Bureau. It is estimated that there were an estimated 1,088 overnight stays in Peoria and the average meal purchases in our community over the weekend were \$52,594. The average shopping in the community was estimated at \$41,835 with recreation purchases at \$34,482. The estimated local taxes generated were \$24,437. The Peoria Art Guild is thrilled to be able to offer this event to the community and make such a significant economic impact on our local economy. The Guild would like to thank the Peoria Park District and all the sponsors and planners who made 2022 a successful year. The Peoria Art Guild is looking forward to the 61st year in September of 2023!
