Body Worlds Rx Opens at the Peoria Riverfront Museum this Spring

Body Worlds Rx, the most popular touring exhibition in the world, comes to Central Illinois and the Peoria Riverfront Museum for the first time on Saturday, May 13, 2023.

This stunning exhibition has been viewed by more than 50 million people worldwide and offers visitors the unique opportunity to dive deep and explore the intricate biology and physiology of human health and the dramatic effects of disease. From organs to muscles to the nervous system and to skeletal structures, BODY WORLDS RX gives unprecedented look inside the most sophisticated mechanism in the world, the human body.

Created by anatomist Dr. Gunther von Hagens, inventor of Plastination and Dr. Angelina Whalley curator of the trailblazing BODY WORLDS exhibitions, the exhibit features real human specimens preserved through Plastination, a technique that removes the fluids from the body and replaces them with plastics that harden.

The specimens on display show impressive comparisons and contrasts between healthy bodies and organs and those stricken with disease. Particular emphasis is put on some of the most common ailments such as back pain, arthritis, cancer, diabetes, obesity, cardiovascular diseases like arteriosclerosis and heart infarctions, dementia, and more.

Body Worlds Rx focuses on contemporary diseases that afflict children and adults and illustrates their causes and effects. The exhibition showcases current research on top health issues that this will inspire guests to adapt a healthier lifestyle.

GOVERNMENT AFFAIRS

News:

In Illinois, many new laws take effect in 2023.

Business & Work:

The annual increases in the state's minimum wage continue, and on Jan. 1, 2023, the minimum wage for most workers increased to \$13 per hour. The minimum wage for those who receive tips for their work (i.e., restaurant servers) will raise to \$7.80 per hour, and the wage for those younger than the age of 18 who work fewer than 650 hours per year will increase to \$10.50 per hour. Annual increases continue until Jan. 1, 2025, when the minimum wage hits \$15 per hour.

SB 1698 Increases the taxable wage base by 2.4% annually beginning in 2023 until 2027 and targeted Unemployment Insurance Trust Fund solvency balance from \$1 billion to \$1.75 billion. Establishes terms for a \$450 million interest-free loan to the UI Trust Fund from the State Treasury.

SB 3120 The Family Bereavement Leave Act (FBLA) gives eligible employees the option of unpaid time off for certain situations. It allows time to grieve the death of a family member covered by the act. It also covers time off for certain pregnancy events, like miscarriage, or other diagnosis that impacts pregnancy. Lastly, it covers adoption related events. Eligible employees will be allowed to use a maximum of two weeks of unpaid bereavement leave.

SB 3127 Formally recognizes emergency medical dispatchers as first responders.

SB 3416 The One Day of Rest Act includes two important changes. First, employees must get one day of rest in "every consecutive seven-day period." And second, employees must get a 20-minute meal break for the first 7.5 hours worked. After that they must get another 20-minute break for each additional 4.5-hour period worked after.

SB 3930 Expands the Illinois Home Grown Business Opportunity Act to include notices of funding opportunities to small businesses and municipalities along the border of Illinois. Requires the Illinois Department of Commerce and Economic Opportunity to notify small businesses and municipalities of new COVID-19 restrictions.

SB 3938 Removes the requirement for the Illinois Department of Innovation and Technology to assist client agencies in identifying funding opportunities and ensuring compliance with all applicable laws, regulations, and grant terms.

HB 5225 Requires the Illinois Department of Commerce and Economic Opportunity to develop a program to award grants to organizations to distribute subsidies to individuals participating in an apprenticeship program, pre-apprenticeship program, or work-based learning program.

School & Higher Education:

SB 3902 Students entering high school in the '23-'24 school year need to complete at least one year of computer science. This is a new graduation requirement. Additionally, all public high school students must complete the Free Application for Federal Student Aid (FAFSA) form. If they do not want to file it, they must waive it. This is a requirement in order to receive their high school diploma.

SB 3925 Creates the Human Service Professional Loan Repayment Program to recruit and retain qualified direct service professionals to work for community-based human service providers by providing loan repayment assistance to eligible direct service professionals.

SB 3972 Creates a program to provide high school students with experience relating to work in the intellectual and developmental disabilities field.

SB 4028 Creates a mental health council that works to figure out how to help children in school to find a mental health provider and how to access the mental health system. Puts into school curriculum lessons and teachings about mental health.

HB 3296 Requires school boards to establish a career and technical education pathway program for grades 6 through 12.

HB 4201 Requires each public university and community college's Board of Trustees to designate a benefits navigator who can assist students with benefit eligibility and how to apply.

HB 4343 Schools can establish wellness checks for students in the 7th grade through 12th grade. The Department of Healthcare and Family Services can also do this. The purpose of these wellness checks is to identify and help students who are at risk of mental health conditions. Some examples of these conditions including depression or anxiety.

HB 4798 Addresses the shortage of substitute teachers throughout the state by allowing students enrolled in approved teacher training programs who have earned at least 90 credit hours to obtain a substitute teaching license.

HB 5265 Requires school districts to waive all school fees for students experiencing homelessness.

HB 5488 Middle school and high school students will be allowed to miss one day of school per year to attend a civic event.

HB 5506 Allows partnership agreements between Community College districts and School districts to allow high school students to enroll in a dual credit course for high school credit and collect demographic data.

Health & Benefits:

Several bills were passed and signed into law that expand insurance coverage for specific screenings and health conditions. Beginning in the New Year, insurance companies must provide coverage for:

- Prenatal vitamins when they are prescribed by a physician
- Prostate cancer screenings with no co-pay required
- Medically necessary Continuous Glucose Monitors for those diagnosed with Type I or Type II diabetes
- Genetic testing to detect an increased risk for breast and ovarian cancer if the tests are recommended by a health care provider.
- Additionally, "home health services" must now be covered for the duration of medically necessary care.

HB 2595 Access to mental healthcare Illinois insurance must cover medically necessary mental health care. This includes treatment for mental, emotional, nervous or substance use disorders.

repayments and scholarships for health care professionals who serve in Illinois medical facilities for a specified period of time. Prioritizes increasing diversity in medically underserved areas.

Money & Debt:

HB 2775 Aims to make it easier for low-income families to find housing by declaring that it is a civil rights violation for any person engaging in real estate transactions to discriminate based on source of income.

HB 4410 Creates the Real Estate Valuation Task Force to help resolve the history of discrimination in the housing industry.

HB 4682 Veterans emergency financial assistance Veterans' Cash grants for emergency financial assistance can be used to pay for past due utilities, housing, and transportation costs.

The American Water Charitable Foundation awarded a \$5,000 grant for a Peoria art project. **Artists ReEnvisioning Tomorrow (ART) Inc.** will repurpose 10 retired fire hydrants donated by **Illinois American Water** to create art. Young student artists of various ages and skill will paint the hydrants while also learning about fire protection and water service. A key partner in this project is the **Peoria Fire Department**, which will help provide programming and auction off the hydrants to donors to raise additional funding for ART Inc.

BeMobile Verizon, is proud to announce that it has been awarded the prestigious “Verizon Agent of the Year” award for 2022. This award recognizes the outstanding achievements and contributions of BeMobile in providing exceptional services to its guests and driving significant growth in Verizon’s mid-major segment.

Seeking to expand its autonomous fleet beyond mining, **Caterpillar Inc.** will collaborate with Luck Stone, the nation’s largest family-owned-and-operated producer of crushed stone, sand and gravel.

Carle Health, a central Illinois-based healthcare system, is proud to welcome the former UnityPoint Health – Central Illinois network along with Trillium Place and Methodist College into its system of care with a focus on improving the health and well-being of the communities it serves. This union will bring an integrated network of three hospitals with 634 beds, more than 850 multi-specialty physicians, 76 clinics, home health and hospice services, a level two trauma center, many advanced specialty services, behavioral health services and a college into the Carle Health team.

A \$35 million Extraordinary Dividend was approved by **CEFCU**’s Board of Directors and distributed to the Credit Union’s member/owners. The amount each member received was determined by dividends earned and interest paid during the first 11 months of the year. On December 1, funds were deposited to members’ Savings accounts. Over the last 22 years, CEFCU has returned \$415 million in Extraordinary Dividends to members.

The **City of Peoria** has distributed \$1.4M to 118 area businesses negatively impacted by the COVID-19 pandemic. With funds from the American Rescue Plan Act, the city’s Economic Development Department launched the RISE (Recovery, Income, Startup, Expansion) program in May 2022. Of the businesses that received funding, 82% are minority-owned, woman-owned, minority-and-women-of-color-owned, and/or veteran-owned.

CityLink recently welcomed Chris Holmquist as the new Director of Human Resources. She is an experienced

HR professional with more than 20 years of experience in the field in both the public and private sectors, and across multiple industries. Holmquist maintains a Senior Professional in Human Resource (SPHR) certification and the Society for Human Resources Management Senior Certified Professional (SHRM-SCP) certification. She is also trained and experienced in Cultural Effectiveness, Diversity, Equity and Inclusion (DEI) and Learning Management. For the past ten years, Holmquist was self-employed with her own HR consulting company based in Colorado.

The **Community Foundation of Central Illinois (CFCI)** announced the selection of the 2023 Ending Hunger Together grant recipients. The Ending Hunger Together Fund was established to address food insecurity in central Illinois by working to create a framework that mixes healthy food access, civic education and community development. This grant was also made possible by the Sow A Seed Fund, which was established to help combat food insecurity issues throughout central Illinois. HEAL Food System Partners, led by the Tazewell County Health Department, and Peoria Grown for their Market 309 project, will each be awarded \$20,000 to continue their work to address food insecurity issues in the community.

Eureka College has received \$1.25 million lead gift for a \$2.5 million project that will create a new Student Success Center and modernize the college library. Inside Melick Library, the 27,000-square-foot center will house all student life and academic support services. Library resources also will be updated. The project is part of a larger initiative to strengthen the school’s First-Generation program and other retention-oriented programs and services. The donor, who wishes to remain anonymous, was a first-generation college student. This fall, 54% of Eureka’s 279 first-year and transfer students were first-generation students. The construction and renovations are planned to begin in spring 2023.

The **Greater Peoria Mass Transit District** was awarded \$5.3 million in grants from the Illinois Department of Transportation. The funding is part of Gov. JB Pritzker’s Rebuild Illinois Capital Program, which provides grants to downstate public transit agencies. This grant money will be used towards the replacement of aging buses in the CityLink fixed route fleet.

OSF HealthCare Saint Francis Medical Center in Peoria has earned a distinguished three-star rating from The Society of Thoracic Surgeons (STS) for its patient care and outcomes in isolated coronary artery bypass grafting procedures. The STS star rating is calculated using a combination of quality measures for specific procedures performed by an STS Adult Cardiac Surgery Database participant. The three-star

rating, which denotes the highest category of quality, places OSF Saint Francis among the elite for heart bypass surgery in the United States and Canada.

The **Peoria Area Chamber of Commerce** welcomes Jessica Linder Gallo as Vice President of Operations. Jessica spent 4 years as the President and CEO at the Aurora Area Chamber of Commerce where she led a Chamber of over 600 member in Illinois' secon-largest city. During her time in Aurora, Jessica received several honors including National Top 40 Chamber Executives under 40 (ACCE) in 2021, State Chamber of the Year in 2020 and 5-star accreditation by the U.S. Chamber of Commerce.

The **Peoria County Board's Advisory Committee for Entrepreneurship and Small Business Development** has launched StartABusinessGP.org, a free, online dashboard for entrepreneurs who are looking to start a business or are in the early stages of development.

The **Peoria County Sheriff's Office** has released a new smartphone app to give easier access to public information. The free app will provide information such as active warrants and an inmate roster, along with an interactive map connected to sex-offender registries. Users can choose to receive message notifications like missing person alerts, suspect information, inclement weather warnings and traffic detours. Information can flow both ways as well, as the app also gives options for anonymous tips and patrol requests.

After a five-month nationwide search, the **Peoria Symphony Orchestra** (PSO) is pleased to announce the hiring of its new Director of Development, Kelly Schneider, who is set to officially begin on Monday, March 20, 2023. Schneider has worked for the Peoria Area Chamber of Commerce since 2021 as the Director of Programming for the CEO Council and the Young Professionals of Greater Peoria (YPGP).

The **Rotary Club of Peoria** has awarded a grant of \$2,747.80 to fund Sterling Middle School's Peaceful Playground updates. The Peaceful Playground is a space that allow students time to just be kids while providing a safe outdoor space to utilize for school and community events.
