What you need to know about the Association Health Plan Pathway 1 Program

- The Manufacturing Association Health Plan is a chamber benefit administered through the Manufacturing Committee of the Henderson Development Association, a Division of the Henderson Chamber of Commerce.
- Employer group's principal place of business must be located in Clark County, Nevada.
- Employer is in the business of manufacturing. See list of SIC codes below.
- 75% of all enrolled subscribers must permanently work and reside within the HPN or SHL enrollment area with no more than 25% of enrollees outside of Clark County, Nevada.
- The employer must be a member in good standing with the Henderson Chamber of Commerce.
- The broker partner must be appointed with HPN/SHL and be a member in good standing with the Henderson Chamber of Commerce.
- Program sponsored by the Henderson Chamber of Commerce in partnership with the Latin Chamber of Commerce, Urban Chamber of Commerce and Boulder City Chamber of Commerce.
