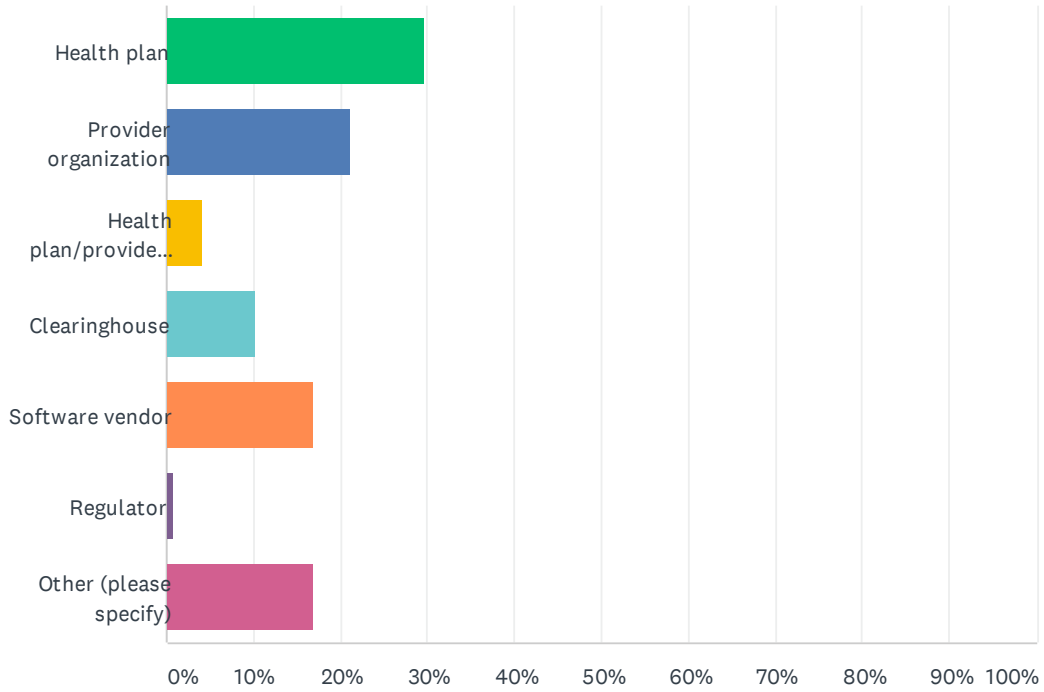


Q1 What best describes your organization?

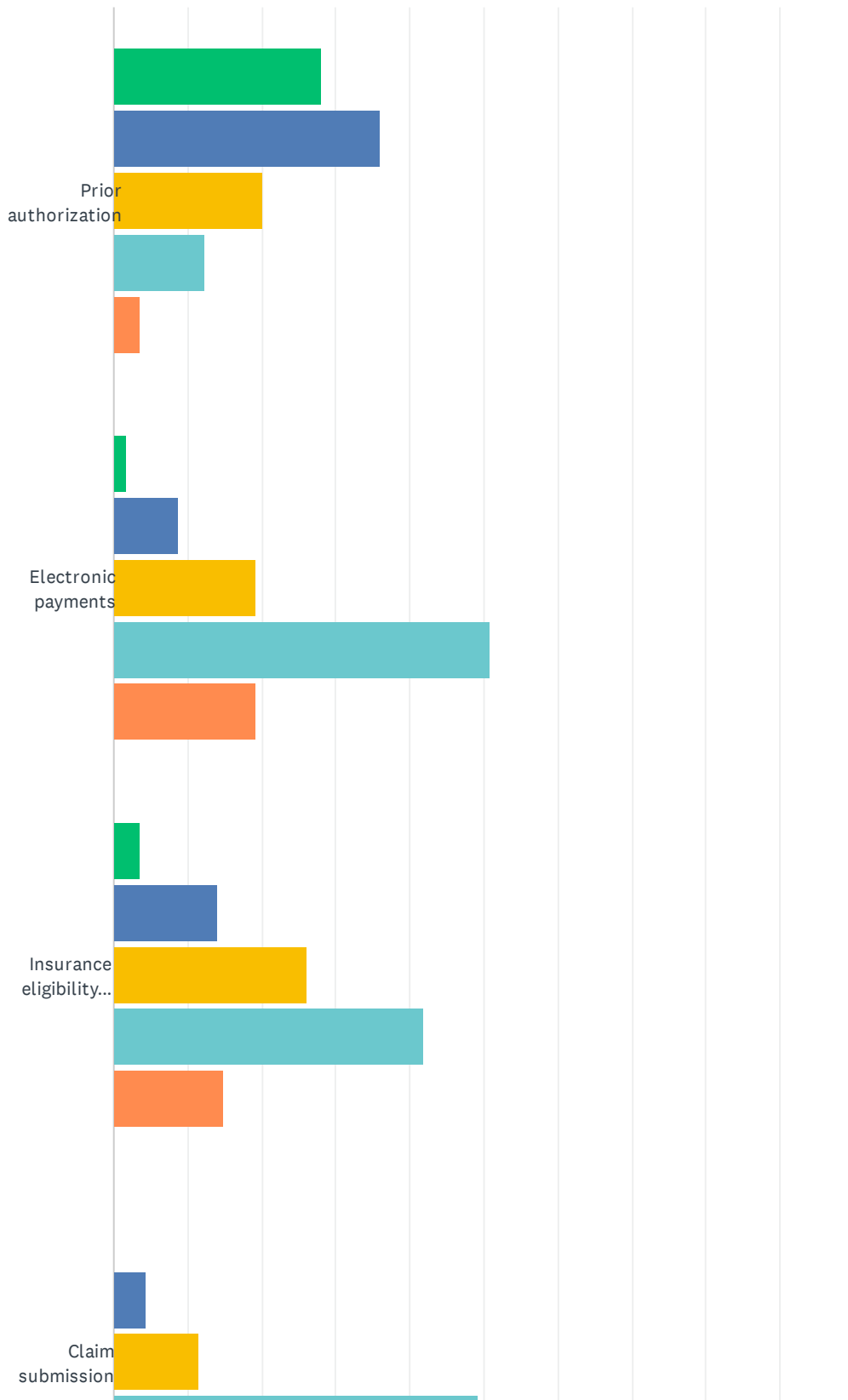

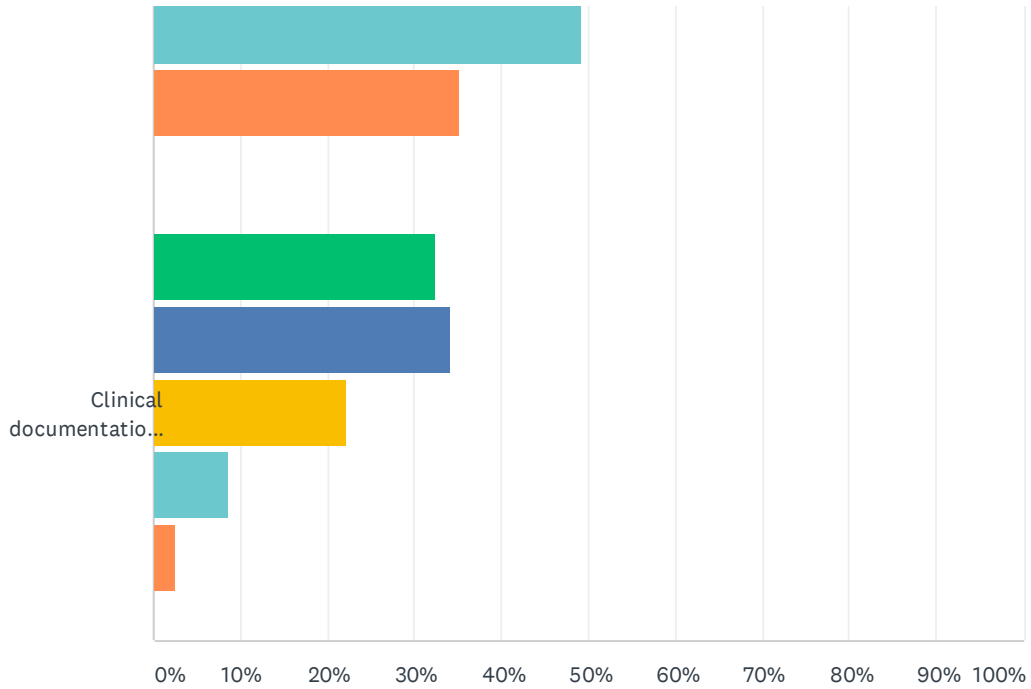

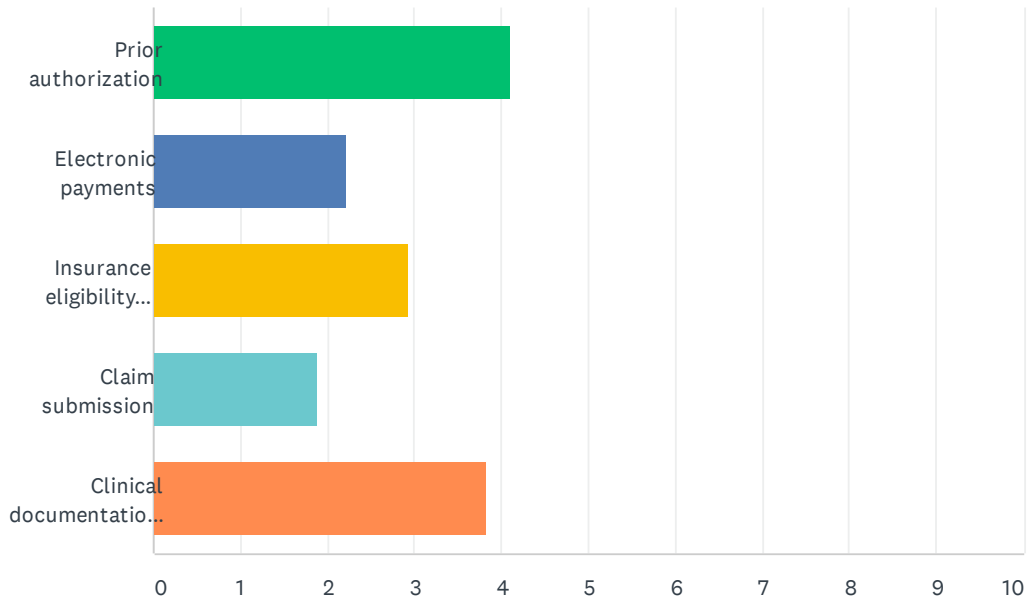

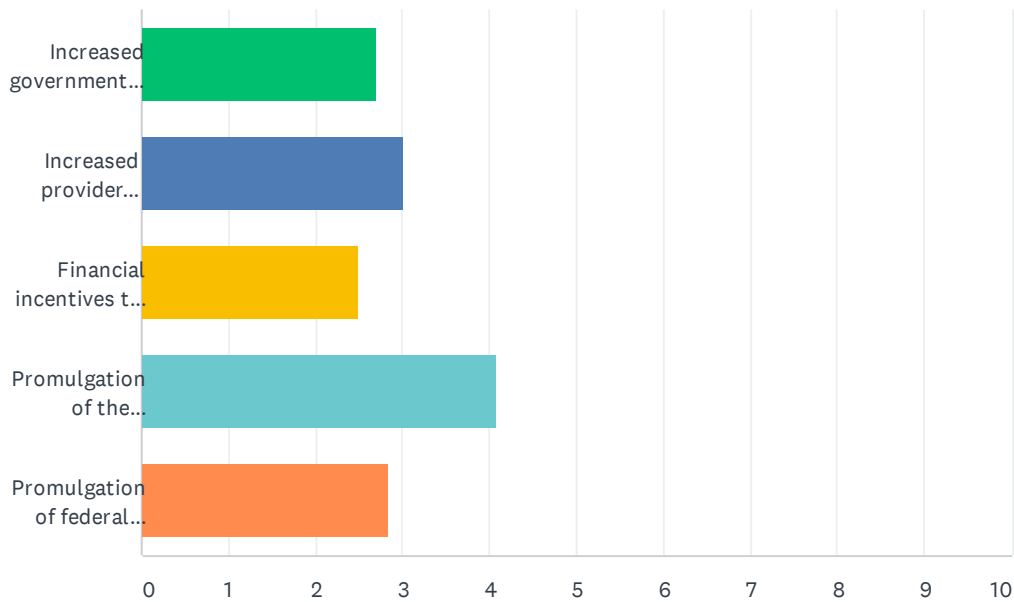

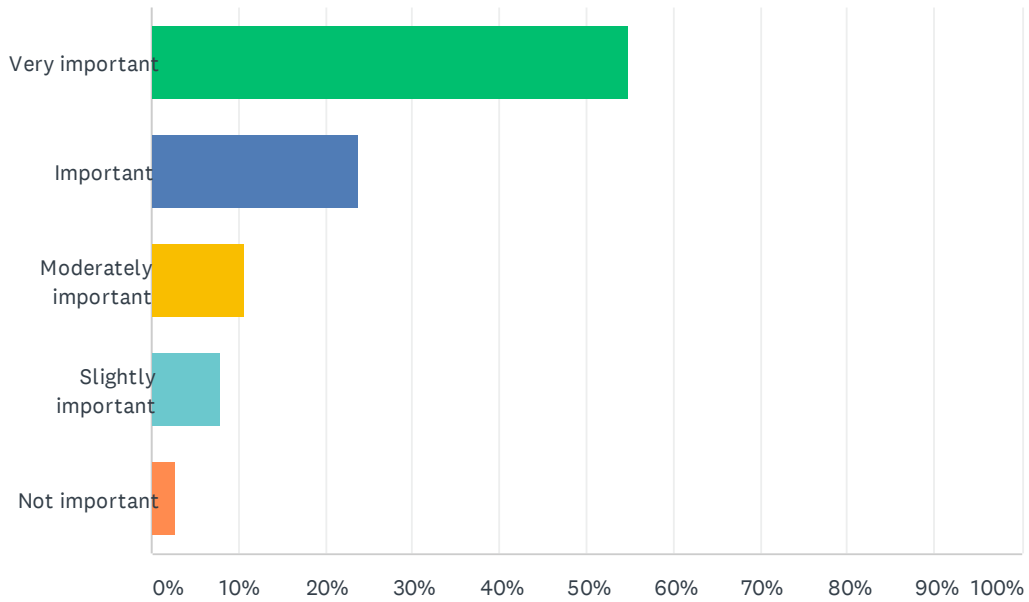

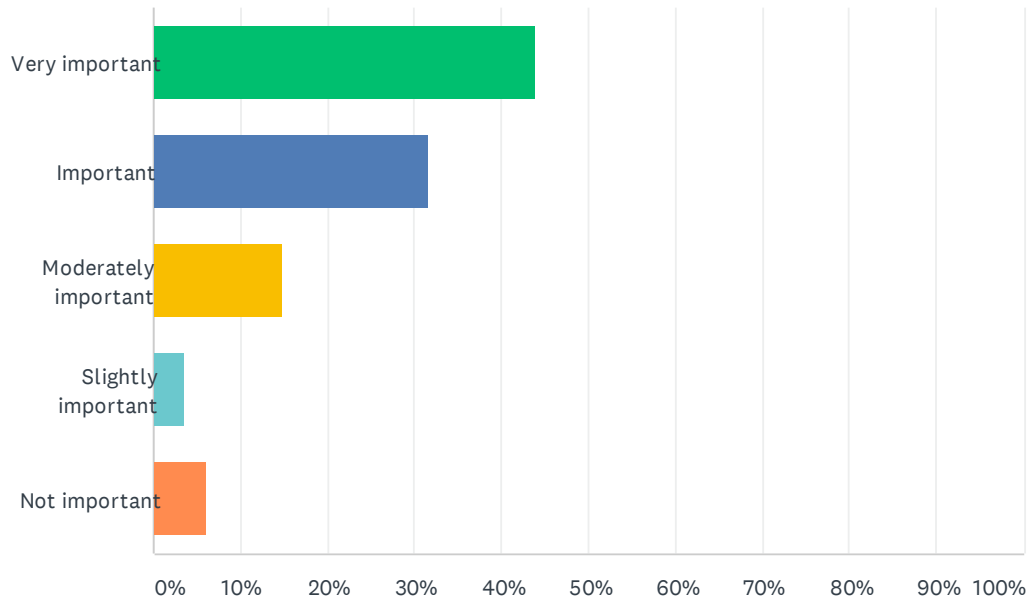

Q8 How important is it for the private sector to pilot new standards?

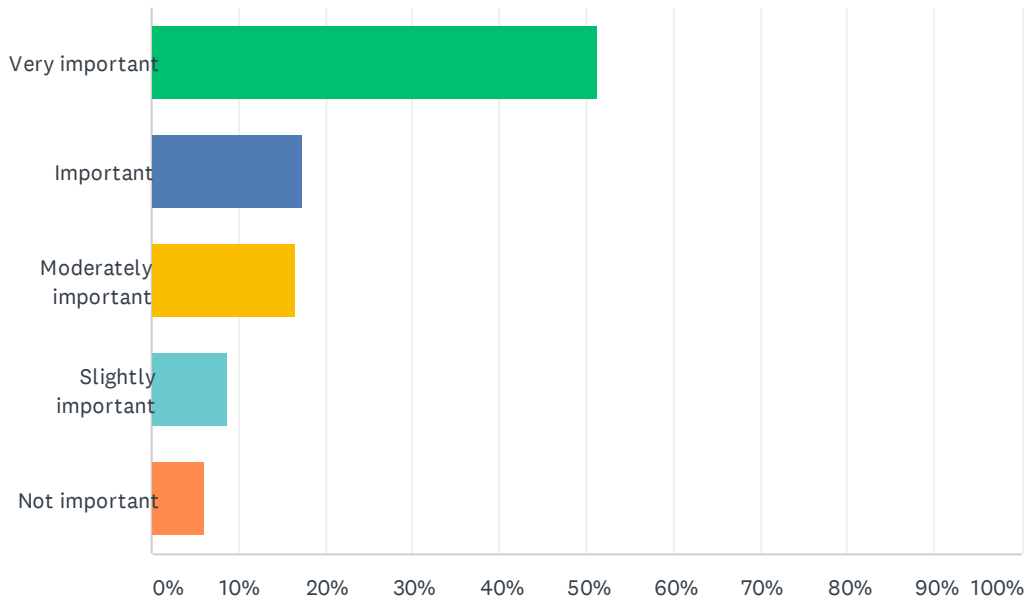

Q9 How important is it for the federal government to pilot new standards?

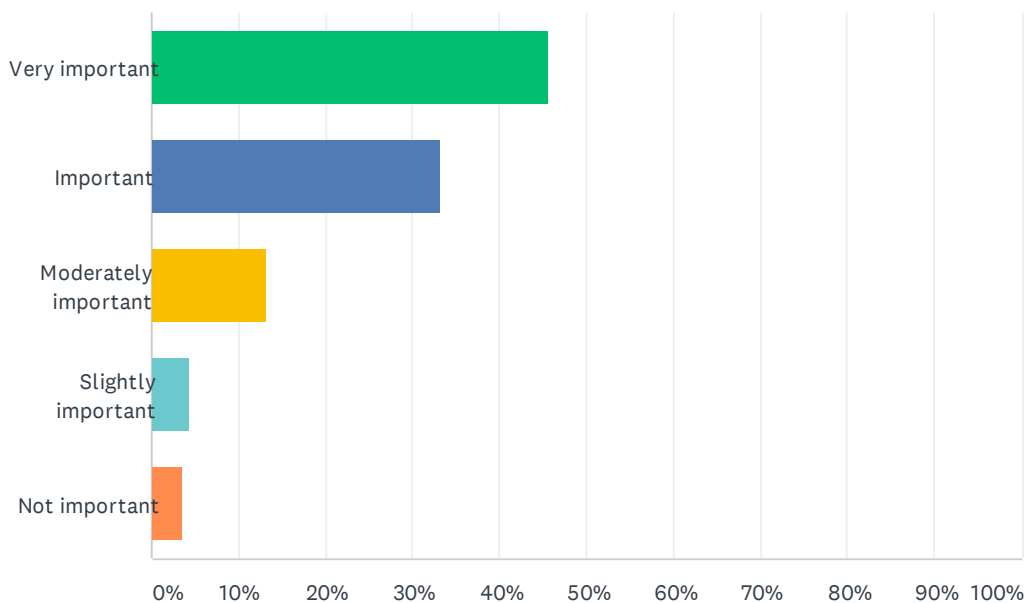

Q10 How important is it for the industry to convene to address the burdens and costs associated with the current administrative transactions?

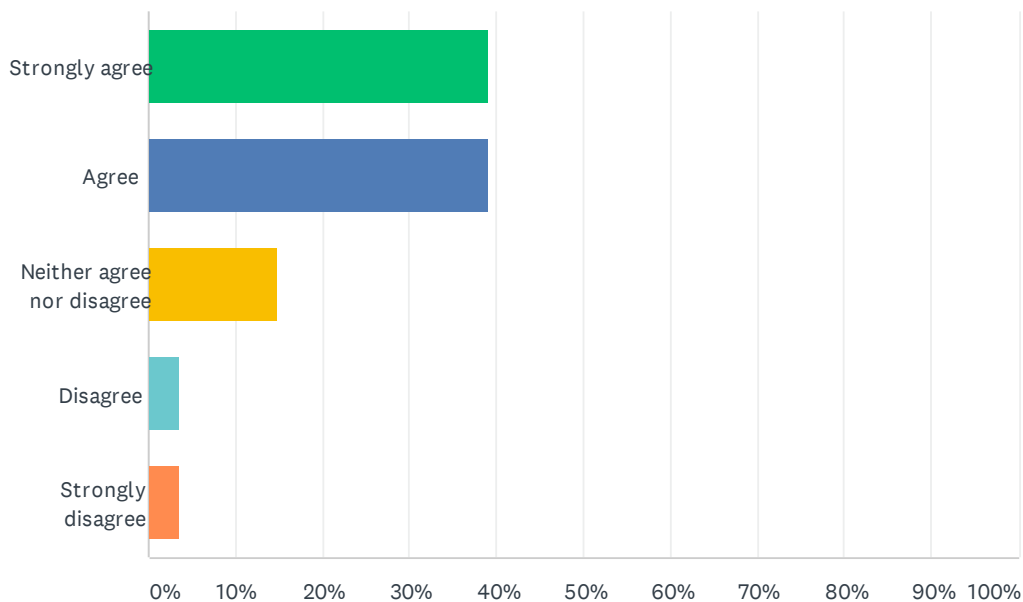

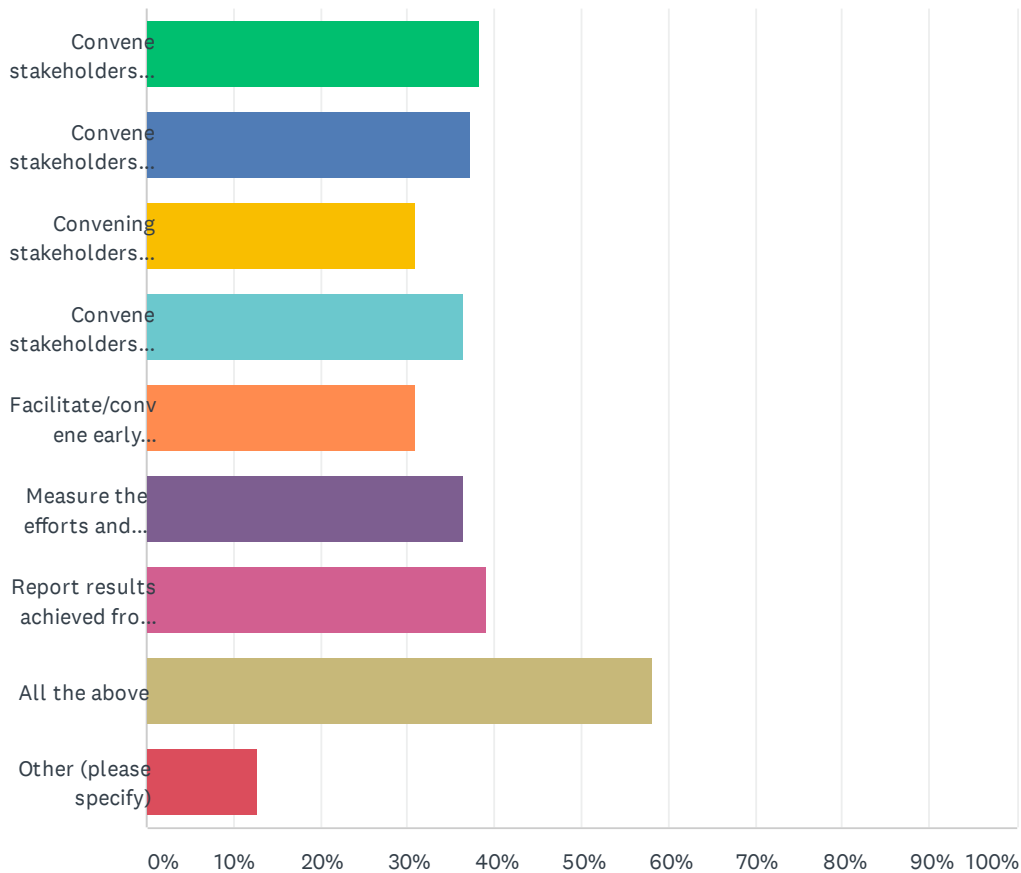
