2.	The Association shall automatically withdraw the membership dues from the bank account designated below on or about the fifth (5 th) day of each month during the term of this Agreement. The Association may also withdraw from the designated bank account a service fee.		
3.	3. If sufficient funds are not immediately available in the designated bank account on the scheduled withdrawal date, the Association may continue to withdraw funds from the account until the amount due is paid in full, or the Association may terminate this Agreement, without notice, and the entire unpaid balance of the annual membership dues shall become immediately due and payable.		
4.	4. The term of this Agreement shall be twelve (12) months beginning on the date set forth above. Following the initial term hereof, this Agreement shall automatically renew for a like term, and from term to term thereafter, in perpetuity, unless either party gives the other party written notice of termination at least thirty (30) days before the end of the then current term.		
5.	5. The Association may increase the amount of the annual membership dues and service fee by giving Member written notice of the dues increase at least sixty (60) days before the end of the then current term. The increase shall be effective on the first day of the renewal term following such notice.		
6.	6. Member may change the designated bank account at any time by giving the Association written notice of the location of the new bank account and the new account number.		
7.	7. All notices required by this Agreement shall be sent by first class U.S. mail, postage prepaid, and addressed to the party to be notified at the address set forth in this Agreement or at such other address as that party may have given the other in writing. Notices shall be deemed given when deposited in the United States mail.		
8.	3. The parties' rights and obligations under this Agreement shall inure to the benefit of and be binding upon their respective successors and assigns.
