

## SOUTH DAKOTA LEGISLATURE UPDATE

This session, the South Dakota Legislature passed several bills to address our

state's need for more affordable housing. Legislators laid the groundwork for these bills by forming an interim committee to study workforce housing needs in South Dakota. Last summer, the committee held public hearings across the state to gather information about housing needs and recommendations for addressing those needs. I appeared at the hearings on behalf of SDHBA.

In response to the interim committee's findings and recommendations, Governor Noem proposed SB 53 which appropriated \$150 million in state general funds and \$50 million in federal funds for housing infrastructure. Under this bill, funds would have been administered by the Governor's Office of Economic Development (GOED). SB 53 passed the Senate but failed in the House because some representatives wanted the funds to be administered by the SD Housing Development Authority (SDHDA) instead of GOED. After intense lobbying by various organizations, including SDHBA, the infrastructure funding plan was revised and passed in the form of HB 1033.

As amended, HB 1033 appropriates \$200 million to SDHDA for the purpose of providing \$100 million in loans and \$100 million in grants for housing infrastructure, including water and sewer systems, streets, curbs and gutters, sidewalks, lift stations, traffic signals, street lighting, and any land necessary for these facilities. Thirty percent of the funds will be available for projects in Sioux Falls and Rapid City and seventy percent will be available for all other areas of the state. Housing infrastructure projects in Sioux Falls and Rapid City may receive either a loan or a grant but not

both. No grant may exceed one-third of the total cost of the project.

In addition to housing infrastructure funding, the Legislature authorized counties and municipalities to provide additional property tax relief for certain newly constructed residential structures. SB 162, which was introduced at the request of SDHBA, gives counties and municipalities the discretion to gradually increase the assessed value of these structures over a period of seven years after completion of construction. During construction, the assessed value of the property may not exceed the assessed value in the year preceding construction.

The Legislature also established a more deliberative process for adopting local building codes. SB 90, which was introduced at the request of SDHBA, requires the Board of Technical Professions to convene a workgroup to review the latest edition of the model national building

codes and identify any significant revisions to the current edition of each code and evaluate the impact of the revisions on quality, safety, and cost of construction. The workgroup may recommend the adoption of any updates to the model codes and alternatives and exceptions to the codes. The workgroup's findings and recommendations will be published on the Board's website. The workgroup, which meets every three years beginning in 2024, will consist of two local building code officials, a homebuilder, a multifamily housing contractor, a commercial building contractor, an architect, and an engineer.

I want to thank the legislators who sponsored these bills, including Senators Herman Otten and Casey Crabtree and Representatives Roger Chase and Greg Jamison. I also want to thank the members of the HBA Legislative Committee for their help in getting this legislation passed, especially Todd Boots.







## CITY SEEKS OUT BROADER STAKEHOLDER INPUT FOR SUSTAINABILITY AND CLIMATE ACTION PLAN

On March 1, 2022, the City of Sioux Falls released the Draft Sustainability and Climate Action Plan (Plan) for a 21-day public comment period. Sioux Falls is a regional leader in water conservation, waste reduction, and energy efficiency. The Plan aims to build upon this foundation and has been in development for 18 months, generating discussion and engagement from the public.

More recently during the public comment period, the City received an extensive amount of additional community feedback after releasing the Plan. The feedback ranged from positive to very concerned. The City received comments from residents, community groups, and associations including the Home Builders Association of the Sioux Empire (HBASE). We received HBASE's concerns about the impacts of the plan and look forward to working with your members in addressing these areas.

Based on this public feedback, and since the Plan intersects with a variety of businesses and industries across our community, the City recognizes the need to ask more questions and reach out to a wider group of stakeholders to capture their input. Collaborating with community partners like the HBASE will be important during this process. We will also work to engage more residents;

commercial businesses; the natural gas and electric utilities; automotive, trucking, and construction industries; and other interested parties. Based on this additional feedback, the City will revise the draft plan accordingly.



Over the next year, the City will work with this broader stakeholder group, including the HBASE, to find commonalities and set realistic goals. To ensure we can carry out this work, we will work on gathering stakeholder input and revising the existing draft Plan before bringing it to the City Council in 2023. Please stay tuned as we seek further stakeholder involvement from the HBASE to refine this Plan as we work together for a more sustainable Sioux Falls.




