Keene State College is moving forward with plans to re-open its campus in the fall to welcome back students, faculty and staff, using risk-mitigating measures to preserve the health and wellbeing of all community members. The College is working with regional partners, New Hampshire Department of Health and Human Services, and Homeland Security professionals to develop evidence-based recommendations and plans to safely return campus to residential operations.

President Melinda Treadwell convened a Contingency Planning Task Force made of College medical experts, faculty, and staff to carefully review data and set conditions for every element of business operations, on-campus classes, and student life. These considerations include testing for COVID-19, careful and frequent cleaning and disinfecting, physical distancing, tracing contacts of those who may be infected, and designated spaces for people in our community who may be ill. It also includes remote learning opportunities for those students who are not able to be on campus due to the virus.

Should plans to re-open residential operations be delayed due to an unpredicted change in the pandemic, Keene State will offer a bridge period of remote learning, or a blended on-campus and remote learning period, to provide robust academic programs and student support until campus does re-open. In the case of a fully-remote learning period, the College will offer additional financial aid, and a reduction in total cost of attendance for students and families.

Keene State is already seeking faculty and student feedback on spring instructional success and potential improvements. The College is also making investments to enhance technology and support faculty as the College develops high quality, blended learning capabilities. These new capabilities will allow Keene State to more seamlessly shift to remote learning,

if necessary, at any point during the year, and provide students with options to meet their individual needs.

"We're getting ready to re-open the doors to Keene State's warm and welcoming community, and we will do it safely. Keene State prepares nurses, teachers, and other professionals who are greatly needed in our communities, and we must continue our work to prepare our future leaders," said Keene State President Melinda Treadwell. "We deeply miss our students and are looking forward to bringing students back to their home and close-knit community on campus. We look forward to welcoming our wonderful community back to campus again, and to welcoming our incoming Class of 2024."

The Town of Swanzey has engaged All States Materials Group to reconstruct Woodale Avenue and Holbrook Avenue from Woodale Avenue to Swanzey Lake Road. The Department of Public Works and other contractors have completed the following portions of this project to date: improving drainage and ditch lines, replacing cross culverts, and removal of

trees within the right-of-way that were negatively impacting the roads.

The primary construction work is schedule to begin the week of June 1st and motorists should expect one lane traffic and minor delays during working hours. The Town expects to complete the first phase by mid-June, which includes reclaiming the existing pavement, graveling, grading and base paving the road and driveway aprons.

The Town expects to complete final paving of the road in mid to late July after the base course has been down for about a month.

The reconstruction of Holbrook and Woodale Avenues is funded by a \$3 million bond for road reconstruction projects approved by voters at the 2019 Town Meeting.

The Town of Swanzey is pleased to announce that the Fire Department has put a transport capable ambulance into active service. The Board of Selectmen authorized the purchase of this used vehicle at their meeting on April 1, 2020 for up to \$55,000 from available capital reserve funds. The Board made this purchase at the recommendation of the Fire Chief and Emergency Medical Response Coordinator in response to the COVID -19 global health pandemic and State of Emergency declared by Governor Sununu in March.

Due to this unprecedented public health emergency and a projected increase of EMS calls in the region, the Town decided it was in the interest of the public safety of the Town's residents to add a backup transport vehicle. The Board of Selectmen will review the operational impact of having an ambulance in October during the 2021 budget process.

The R.J. DiLuzio Ambulance Service provides the Town's primary ambulance coverage and all contractual and operational agreements with Mutual Aid Departments remain in effect. The SFD Ambulance, now known as 27-A1, will serve in a vital role if needed to transport patients in the event the contracted ambulance service is unable to do so.

"I am extremely proud of all the members of the SFD, especially Captain Brandon West, Captain Eric Mattson and Deputy Chief Mick Sanchez as these members were instrumental in making this happen. The SFD strives to serve the citizens and visitors of Swanzey with the utmost professionalism and the highest level of care we can provide. This ambulance will allow us to do that in this time of need. I want to sincerely thank the Board of Selectmen, Town Administrator Michael **Branley** and the Keene Fire Department for their assistance, continued support and strong cooperat ion allowing us to move forward," said Fire Chief William Gould.



The Town of Swanzey is announcing that a public informational meeting to discuss the proposed Replacement of Christian Hill Road Bridge over Ashuelot Rail Trail – NHDOT Bridge No. 098/122 on Wednesday, June 3, 2020 at 6:00 p.m.

The Town's Engineer (Hoyle, Tanner & Associates, Inc.) is developing an engineering study for the replacement of the existing bridge and reconstruction of approximately 300 feet of Christian Hill Road. The purpose of the project is to replace the Christian Hill Road Bridge to provide a structurally safe bridge while minimizing environmental impacts, construction duration, and project costs. The need for the project is due to the structurally deficient condition of the bridge, which has been closed to vehicular traffic since 2014 due to its deteriorated condition, although it is still used by pedestrians.

True Hope Therapeutic Horsemanship was created by a group of women who came together in January 2018 with a common goal in mind and a mission: "To help humans and horses find the therapeutic benefits of horsemanship by providing therapeutic horsemanship lessons and promoting the ethical use of equines." The founders have all worked with horses and many of them had volunteered or worked at Miracles in Motion, a therapeutic riding program that closed in September, 2017.

Horses can be very therapeutic for humans. Physically, the rhythmic motion of a horse's gait can mimic the natural human gait. Emotionally, the interaction and connection between a horse and a human helps develop a sense of empathy, a sense of empowerment, increased trust, and increased self-confidence and self-esteem. Horses are cognitive and sentient beings and can create unique bonds with the people who work with them. For horses, human interaction can give them a sense of fulfillment.

True Hope Therapeutic Horsemanship provides therapeutic horsemanship lessons to participants who are living with one or more physical, cognitive, emotional, social, or behavioral challenges. They also advocate for the ethical uses of equines, focusing on their lesson horses, with the transparency of their own program. True Hope Therapeutic Horsemanship is currently operating out of two activity sites in Troy and Westmoreland, NH.






