

President's Corner

A letter from Phil Suter, President &CEO



Greetings Chamber Members –

Just about a year ago, we began to hear about a new (Covid-19) coronavirus outbreak. The year since has been unlike anything most of us have ever seen – economically, politically and personally – here

in the Monadnock Region and around the world. Public health considerations required restricting some of our movement and the way we gather as a community, and how we do business on a day-to-day basis.

Many of our Chamber members continue to face challenges, and we're all pitching in to help.

Monadnock Region communities have done an amazing job of supporting their local businesses, and businesses all over the region have pivoted to meet the moment. We're resilient, and we will bounce back. That's who we are.

It's been a busy year for our Chamber and we've had to make some adjustments as well. Our staff is still working remotely some of the time, and our Central Square office in Keene is not yet open to the public. We're all looking forward to returning to some semblance of normal.

Here are a few of the things we're working on:

1. We completed our merger with the Greater Peterborough Chamber late last year, and we will now be known at the Greater Keene & Peterborough Chamber. Our logo is a little different, and our commitment to providing value for our members is stronger than ever, but it's going to take some time to fully integrate our operations. 2021 will be a transitional year, and we're excited about it! Please let us know if you have questions, and/or would like to help.

- 2.We were fortunate enough to be part of the NH Department of Business & Economic Affairs' Chamber Partnership Program in the last quarter of 2020. This program was designed to help Chambers in the state through these challenging times by supporting our efforts to provide assistance to members, while positioning ourselves for a strong recovery from the impact of the COVID crisis. Under CARES Act and GOFERR rules, all funds had to be spent by December 30th, so it was a hectic time. Emphasis on how the funds were spent was placed on promoting the Monadnock Region, and on the merger, as well as COVID safety and workforce issues.

- 4. We will be continuing to "promote the region" in 2021. We have two plans for doing that. The first is designed based on receiving a Federal EDA grant. We submitted a very competitive proposal in 2020, and we are awaiting a response (we hear it may be considered by a review committee in the next month or two). If there is no EDA funding, we are developing an alternate plan, based on local funding. Stay tuned.

In addition to all of this, we will continue to serve you every day – helping you promote your business, and presenting programs that inform, educate and inspire our community to continue the collaborative spirit that makes this region great. Thank you for being a Chamber member.

The **Monadnock Food Co-op** Farm Fund program, in partnership with the Cheshire County Conservation District, is now accepting applications from local farmers. Currently, in its fifth year, the fund has supported nine farms in the

Monadnock Region.

This year, the Farm Fund will award up to \$30,000 to help farms in Cheshire County and abutting New Hampshire towns develop or expand their production for wholesale markets, including selling to the Monadnock Food Co-op and Food Connects. Farmers may apply for grants ranging from \$500 to \$10,000. Funds can support a range of projects, including the purchase of equipment and infrastructure, packaging and labeling design needs, and technical assistance.

A Request for Proposals and an application are available at monadnockfood. coop/community/#farm-fund. Applications are due February 1, 2021.

Tax-deductible donations to this fund can be made to the Cheshire County Conservation District at cheshireconservation. org/make-a-donation. Additional fundraising activities will occur at the Monadnock Food Co-op, including a Round It Up Donation Drive in January and February 2021.

Right down the road, right now, someone needs a ride to somewhere essential.

And volunteer drivers for Community Volunteer Transportation Company (CVTC) drive people where they need to go.

When riders can keep their essential appointments, they stay independent, and can live at home in peace. Riders can request to be taken to their doctor's or social service appointments, pharmacy or grocery shopping; all non-emergency. A five business-days' advance notice is all CVTC needs to enter a rider's trip request in their TripList system. And for the rider, it is more than just the free ride. Our drivers are courteous and trustworthy, willing to converse and engage. Sometimes even new friendships are made.

Once vetted volunteer drivers choose which trips best fit their schedule, they call the rider to verify pick-up times and, when they return home themselves, they track their total mileage for reimbursement from CVTC. Drivers select when, and to where,

and for how long they are available. By making this difference in a rider's life, drivers contribute to the health of the Monadnock Region, one person at a time. Call CVTC for more information at (877) 428-2882 ext 5.

Northeast Delta Dental recently awarded grants of \$40,365 to eight New Hampshire oral health programs through the Northeast Delta Dental Foundation, established 25 years ago to support oral health programs in Maine, New Hampshire, and Vermont.



Ask the Expert

What are some Do's and Don'ts when it comes to Virtual Meetings?

It is quite amazing how quickly we have all pivoted to virtual meetings, whether for one-on-one discussions, large group gatherings and everything in between. One of the best things we can do is to set clear guidelines (expectations, rules etc.) so people understand the guard rails they are operating between in a virtual meeting. Here are some of the basics to help make for great meetings:

- Do a tech check! For people running the meeting, make sure people are familiar with the key features of the platform being used. Get the log-in info (and agenda) out well ahead of the meeting with clear instructions. For attendees, log-in a few minutes early to make sure you can connect (which especially important if kids are in a Zoom classes at the same time, sucking all of your bandwidth).
- Who's turn? The larger the meeting is, the more important it is to have a process for having the "floor". Most platforms have some form of virtual hand-raising (emojis) that work well.
- Multi-tasking This is a tough one since there are so many tempting distractions. To run a crisp, efficient meeting, be direct on importance of being present and not playing Candy Crush while the CEO is speaking!
- Chat room Be clear if the chat room is to be used as part of a meeting. Things can devolve quickly if there are simultaneous verbal and written conversations happening.
- Lighting Light should be focused on you from behind the camera, not behind you. The later makes you more difficult to see.
- Use muting correctly This means unmute when speaking; mute the rest of the time. Always make sure to check if you're muted before speaking. (2020 phrase of the year: You are muted!)
- Backgrounds My best advice is two-fold: (1) Skip the phony backgrounds unless absolutely necessary (as in you forgot to make your bed) and (2) Check what your background looks like before you go live. Most platforms have a preview feature.
- BONUS: Schedule meetings in anything other than half or whole hour increments e.g. 45 minutes (my favorite). People need time between meetings this helps to build in breaks that help keep everyone focused during the meeting.

Mask Guidelines for Retail

The New Hampshire Retail Association has been working with the NH Attorney General's Office, the Governor's Office and the Department of Business and Economic Affairs to develop guidelines to insure that retail employees are kept safe when customers refuse to wear a mask.

The Attorney General's office issued guidance on how businesses should handle these situations. Retail employees are urged to call the police and not engage with the customer after the refusal. Be sure to call your local law enforcement department prior to an issue to establish a plan with them.

The Monadnock Restaurant Project: Eat, Drink & Build Community

The Local Crowd Monadnock, Culinary Journeys, and Food Connects have partnered to launch The Monadnock Restaurant Project, a homegrown stimulus effort. A virtual press conference was held on February 3rd to introduce the project and answer questions.





This project will invest \$10,000 to purchase gift cards from participating locally owned restaurants. The group plans to strategically disperse these gift cards to community members who will spend the cards quickly, providing an immediate shot in the arm to Keene's local economy this winter.

"It could be a really rough few months for our fellow restaurateurs and if we don't do something soon, we could lose some of the businesses on the edge," said Luca Paris, owner of Luca's Mediterranean Café. "We can't wait for someone else to help us. Eat, drink and build community! Let's do this as a community—quickly and safely."

The project team anticipates that community members will spend twice the amount of their gift cards when redeemed, doubling the impact of this project by infusing \$20,000 to these cash-strapped businesses.

According to the Monadnock Indie Impact Study, locally owned retailers return 62.4% of their revenue to the local economy, while national chain retailers return just 13.6% of revenue—meaning that locally owned businesses return over 4x more money to the local economy compared to chain retailers.

Culinary Journeys is funding Phase 1 of the project and invites local community members to fund future rounds.






