As you drive through and pass local properties in our area, you may not realize the hand that the Chamber and CADC played in developing those places.

There are several business parks, including the large project near Exit 24 on I-81, that are thriving due to the diligent work of our CADC affiliate, as well as other local



development organizations that work hand-in-hand with us. To get a sense of the properties that we have developed, and continue to develop, I invite you go to the CADC page of our website and check out the fantastic drone footage that was just released at our annual CADC business luncheon. CADC may be most recognized for developing business parks, but we are shifting our focus to developing the downtown area as well. CADC partnered with the Franklin County Area Development Corporation and invested in the Rose Rent Lofts at the former Central Junior High School which should near completion in Spring/Summer 2019. We also partnered with Habitat for Humanity to convert properties near Memorial Square back to single family homes. The first home was completed in 2017. Contributions were also made to many other projects including the Coyle Free Library, Capitol Theatre Center, and the Central Parking Lot adjacent to the Shook Rehabilitation & Wellness Center. I'm excited to watch our downtown area continue to change and flourish and know that the Chamber and our affiliates play a part in making it all happen.

Over the Rainbow Children's Advocacy Center (OTR-CAC) provides a safe, child-friendly place for children and their families to receive services that help to restore hope and provide healing from child abuse.

Children's Advocacy Centers minimize the trauma that can be experienced by a child during a child abuse investigation. This is done by utilizing a multidisciplinary team response to child abuse.

Services are provided onsite for the child and their family. Services include a forensic interview which allows the child to tell their story while members of the investigative team watch the interview through close circuit television. This approach helps to eliminate the number of times a child will have to tell their story. A victim advocate is present at the center to meet with the caregiver and provide support and referrals for services. The child is also offered a forensic medical exam.

Over The Rainbow CAC is a 501-C3 non profit organization and all services are provided at **No Cost** to children and their families thanks to the generosity of individuals, businesses, organizations, and public agencies. Since 2014, Over The Rainbow CAC has provided services to over 800 reported child abuse victims.

PA CHAMBER UPDATE

Businesses urged to weigh in on Pa overtime eligibility requirements

A 30 day extension has been granted for the general public

and employers to submit comments to the Independent Regulatory Review Commission regarding proposed changes to Pennsylvania's overtime eligibility rules, which were unveiled a few weeks ago by the state Dept. of Labor and Industry.

Commenters now have until Wednesday, Aug. 22 to analyze the impact these rule changes would have on their business and provide their views to state regulators. The PA Chamber had coordinated a coalition letter requesting the extension.

To recap, the changes include a wage threshold for "exempt status" that is more than double the current rate set by the federal government. There would also be significant revisions to so-called "duties tests," which are also used to determine eligibility.

Finally, the rule would establish an automatic update to the salary threshold every three years beginning in 2023. Similar changes were proposed at the federal level a few years ago and decried by many employers, nonprofit organizations, human service agencies and others as financially unviable and likely to cause unwelcome changes to workplace culture and morale as employees are forced to be shifted from salaried to hourly status. Following the outcry, the proposal was ultimately struck down by a federal court.

PA Chamber members are encouraged to learn more about the full impact of these proposed changes by visiting our website (where they can also write an email to IRRC); and by signing up for a free webinar on Thursday, July 19. From 11 a.m. to Noon, employment defense attorney Josh Vaughn will cover the breadth of these changes; how employers may have to plan to comply; which employees would be eligible for overtime under the new standards; how to convert their status from salaried to hourly; and more.
