#### Nominee for first term on the board of directors.

#### Nominee for first term on the board of directors.

# Leadership Franklin County Youth discusses diversity



Leadership Franklin County Youth (LFCY) were back to school with their first session of the new school year. On September 11, the students met at **Wilson College** for a session led by Maria Banks of the **Chambersburg Area School District** beginning with an overview of leadership principles to be explored during the upcoming sessions. Banks introduced the five leadership practices outlined in their textbooks by James Kouzes and Barry Posner: Model the Way, Inspire a Shared Vision, Challenge the Process, Enable Others to Act and Encourage the Heart.

Sessions also included a discussion on diversity. Banks led the students through exercises designed to help the students better understand themselves and others. They discussed the similarities and differences they have with others. Various exercises were also used to examine uncontrollable factors that impact their lives. The students talked about how they can use this knowledge to demonstrate leadership. After lunch, the students spoke about their community service projects for the year. The students will work with the Teens for a Better Tomorrow to expand last year's Be Kind initiative to all the schools in the county this February.


#### PA CHAMBER UPDATE PA tax code analysis

This article was written by the Pennsylvania Chamber of Business and Industry.

The PA Chamber unveiled a new study recently, "Pennsylvania: A 21st Century Tax Code for the Commonwealth," that presents a comparative analysis of the state's tax structure with other states and provides a menu of policy options to improve Pennsylvania's tax system and overall competitiveness.

Compiled by the Tax Foundation and funded via a grant from the PA Chamber, the report shows that Pennsylvania relies more heavily on corporate taxes as a revenue source than most other states. According to the U.S. Census Bureau, 4.7 percent of Pennsylvania's state and local tax collections come from the corporate income tax, while the national average is 3.7 percent. The heavy reliance on volatile corporate taxes can make the state's budget process more difficult. The report ranks Pennsylvania fourth among the states in terms of corporate income tax collections, while the state's corporate income tax structure ranks seventh worst in the nation.

During a recent media call, PA Chamber Government Affairs Vice President Sam Denisco expressed optimism that elected officials will have an appetite in the upcoming legislative session to adopt some of these much-needed, long-overdue recommendations. While Denisco acknowledged that strides have been made in recent years to boost the state's competitiveness, he said that a reduction in Pennsylvania's 9.99 percent Corporate Net Income Tax rate and a full elimination of the cap on Net Operating Losses would significantly improve the state's opportunities to attract investment and create jobs.
