ABOUT GREER FAMILY FEST

GENERAL INFORMATION

MEDIA CATEGORIES

You must submit at least two slides or pictures per medium and one picture of booth display. Art must be hung or freestanding. Nails or stakes in the ground are not permitted

Artists must be present during the entire event and must personally staff their exhibit space. No agents, dealers, or representatives may attend the event in place of the artist.

Exclusivity of items sold at Greer Family Fest is not guaranteed.

ENTRY FEES

ARTISTS BOOTH : \$99

This includes one 10'x10' space.

DOUBLE BOOTH: \$149

This includes on 10'x20' space.

A late fee of \$25 will be required if submitted after March 31, 2020.

• **One 110 volt/15 amps single plug outlet may be requested - please note this on application. We will do our best to accommodate power needs, however, we cannot guarantee that you will receive power. We suggest battery operated lighting.**

• Vendors are required to provide tents, tables, chairs, display units, extension cords, and lights.

• Please enclose a check for your Entry Fee with application. This check will only be deposited only upon acceptance into the festival. Check for applicants that are not accepted will be voided immediately.

Exhibitors must comply with all state and local laws and regulations, including but not limited to laws and regulations concerning taxation, health, safety, labor, employment and licensing laws.

All exhibits must remain totally intact and operational until the festival closes on Saturday at 10:00pm

RAIN DATE/REFUND

There is no rain date for the Greer Family Fest and no refunds.

WITHDRAWAL

Once you have been notified of your acceptance to Greer Family Festival, your entry fee is non-refundable.

SALES

Vendors will retain all revenue from sales, and are responsible for all currency-related issues.

CLEAN UP

Each Vendor is responsible for his own exhibit area at the end of each day. Vendors are asked to maintain their booth space clean and free of rubbish. Trash containers are available to dispose of trash.

BOOTH ITEMS LIABILITY & SECURITY

Items brought on site are done so at the sole risk of the Vendor. Greer Family Fest is not responsible for any loss, damage, or destruction of personal property, equipment, and/or valuables. It is recommended that Vendors remove any valuable items from the booth at the end of each day.

Greer Family Fest will have overnight security at the event, but is not responsible for security at each vendor location.

TAXES

Vendors are responsible for complying with local and state tax regulations.
