



# 2020 Crime Mitigation Grant Application

## Overview

The Crime Mitigation Grant (CMG) is a pilot project that would allow for limited capital funding of projects brought forward by residents, businesses, not for profits, associations, charities who have a substantiated reason to believe this project has the likelihood of mitigating their concerns related to crime or social disorder.

A total grant allocation of \$50,000.00 is available; however, a single application may be funded to a maximum of \$10,000.00. **The deadline for application submission is July 1, 2020.**

The Committee will evaluate the proposal(s) using a matrix made up of the following considerations:

- a) A validated crime/social disorder concern, which exists or is likely to exist
- b) A review of what measure(s) the applicant or the City has taken to date
- c) Determine the individuals' vulnerability and risk factors
- d) The extent of the impact being experienced by the applicant
- e) The cost of the proposal, the amount of Grant funds available, and whether the applicant should have a financial contribution
- e) The likelihood the proposal will achieve the desired result
- f) Alternatives to the proposal

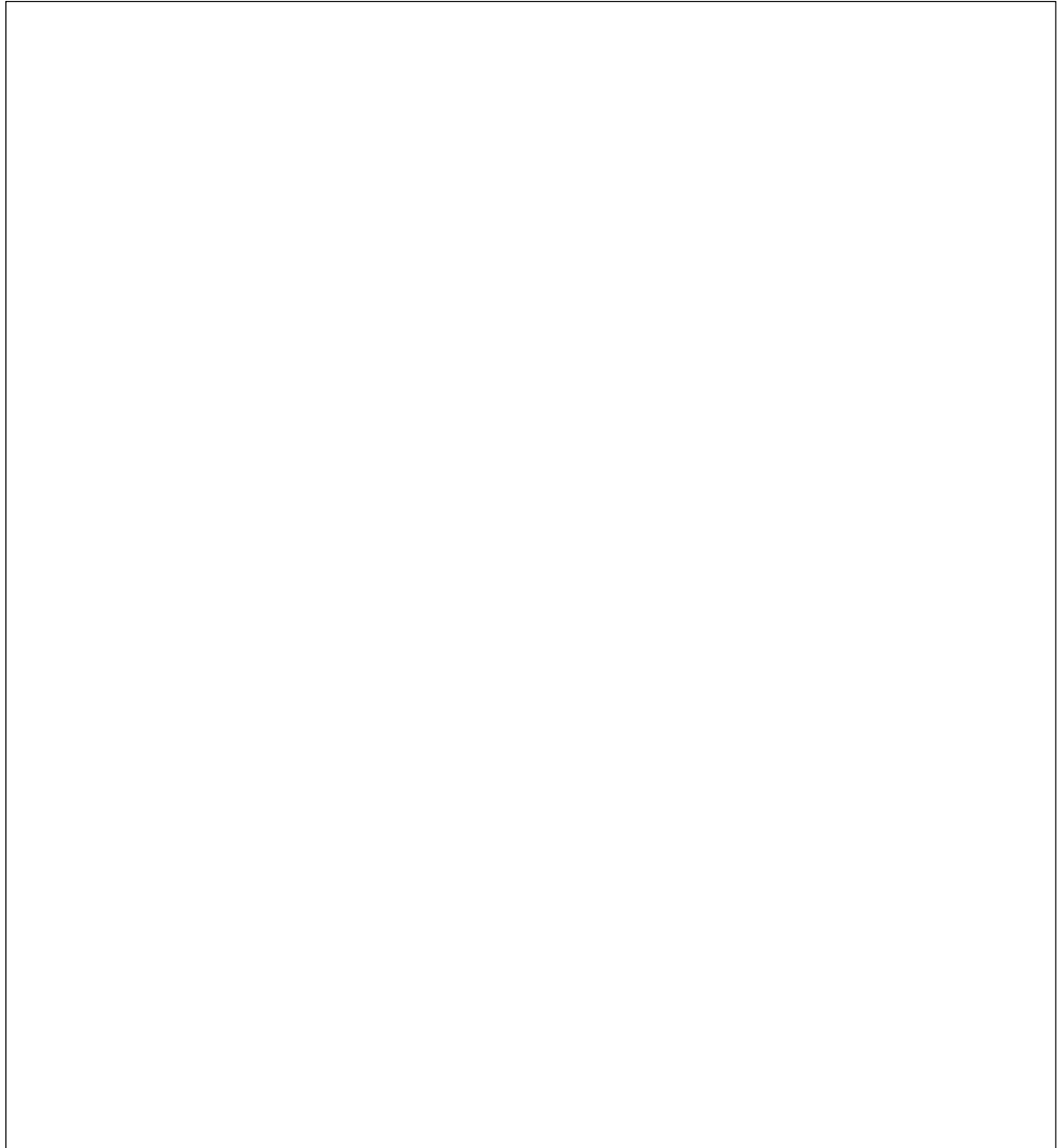
