ELIGIBILITY

Any company that has been in business for five years or less and that has significant operations in Jefferson, Lewis, or St. Lawrence County. Nominees do not need to be a Chamber member. Business cannot be a buy-out of an existing company. May not have previously won a Business of the Year Award in this category.

CRITERIA

Company will be recognized as an up and coming business based on the actual or potential growth of its business, innovative products, or services.
