Contest Rules

ONLY ONE RECIPE PER ENTRANT WILL BE ACCEPTED.

Exclusion of Eligibility

Employees and representatives of AFSC, affiliated corporations and other persons, as well as members of their households and their immediate families, are not eligible to win the contest prize.

Prizes

Prizes must be accepted as awarded. No substitutions or alterations of the prizes are permitted, nor will any cash equivalent be paid. AFSC reserves the right, in its sole and absolute discretion, to limit the number of prizes offered and to accept, withdraw, or decline any prize.

- All winners will be featured on AFSC's social media and/or website, and either their recipe or a story about their recipe will be highlighted in AFSC's monthly newsletter, *Field Notes*.
- Winners will also be announced on the Taber & District Chamber of Commerce's social media and in the following week's Taber & District Chamber of Commerce e-newsletter.

Judging: Finalists are required to present their dishes to the AFSC tent by 5 p.m. August 26, at which time each entry will be assigned an entry ID number .

Judging will take place from 5 until 6 p.m., at which time the prize winners will be chosen and announced on stage after 6 p.m.

Recipes will be judged by a (assigned) panel of judges and given points based on the following criteria and point system:

- Taste (1 to 40 points)
- Texture (1 to 20 points)
- Creativity (1 to 20 points)
- Visual appeal/presentation (1 to 20 points).

In the event of a tie, the entry with the highest score in the taste category and, if necessary, the texture category, will be the winner.

General Terms and Conditions

AFSC reserves the right, exercisable in its sole discretion, to disqualify and ban any individual from participating in the contest if the individual is found or is believed to have been tampering with the entry process, the operation of the contest or if the individual is found or is believed to have been attempting to contact, threaten, annoy, harass, or abuse any person in relation to the contest.
