RULES AND RELEASE FOR BERMONT SHOOTING CLUB, INC

Shooting rules will be strictly enforced. Anyone who shoots or is a spectator at Bermont Shooting Club, Inc must have a signed and witnessed copy of these rules and release on file. Shooting or spectating without a signed consent form will be considered to consent to its terms and conditions with or without a signature. Shooters and spectators who have not previously used the facility must identify that fact on their initial visit to the club. The following applies to all shooters and to those who are signing on behalf of minors, collectively, "Participants".

- 1. The participant (whether Minor by Parent or Guardian or Adult) HEREBY ASSUME FULL RESPONSIBILITY FOR AND RISK OF BODILY INJURY, DEATH OR PROPERTY DAMAGE due to negligence of Releases (as identified below) or otherwise while in or on BSCI property for any purpose. The undersigned recognize and understand there are risks and dangers associated with participation or observation of shooting sports that could cause severe bodily injury, disability and death. Further, the risks and dangers may be caused by the negligent failure to act of the Releases' and others. All of the risks associated with participating in the Event/and or entry are assumes and notwithstanding.
- 2. The participant (whether MINOR by PARENT or GUARDIAN or ADULT) release, waive, discharge and covenant no to sue the Releases', associations, sanctioning organizations (or any affiliates thereof) range operators, officials, owners, lessees and lessees of premises, and for each of them, their officers, agents and employees (all for the purpose herein referred to as ("Releasees") from all liability to ourselves, the undersigned's, our personal representatives, assigns, executors, heirs, and next of kin for any and all claims, demands losses or damages of the Participant (whether by MINOR by PARENT or GUARDIAN or ADULT) on account of any injury, including, but not limited to death or injury of the Participant (whether MINOR by PARENT or GUARDIAN or ADULT) all of which is caused or alleged to be caused by the negligence of the Releasees or otherwise.
- 3. The participant (whether MINOR by PARENT or GUARDIAN or ADULT) hereby agrees to indemnify release and hold harmless, the Releases and each of them from any loss, liability, damage or cost they may occur due, in any manner or degree to the presence of the parent/guardian or the participant (whether MINOR by PARENT or GUARDIAN or ADULT) or related in any way to the participation in or presence on Premises and whether caused by negligence of the Releases or otherwise. The parent and/or guardian further recognize and agree they are executing this Waiver and Releases of Liability and indemnity Agreement on behalf of the Participant.
- 4. This Release and Waiver of Liability, Assumption of risk and Indemnity Agreement extends to all acts of negligence by the Releasees. INCLUDING NEGLIGENCE RESCUE OPERATIONS and is intended to be as broad and inclusive as permitted by the laws of Florida and that if any portion thereof is held invalid. It is agreed that the balance shall notwithstanding, continue in full legal

force and effect. The participant also agrees to follow all rules, as well as any updated or changed rules which may be posted about the property. Think "SAFETY FIRST & ALWAYS". There will be no loaded guns to and from the shooting stations. Guns can only be loaded at the shooting station after the area is secure. Keep loaded guns pointing in a safe location at all times. When not at a shooting station your gun must be carried unloaded and with the action open at all times. There will be no shooting at any other location at Bermont Shooting Club, Inc other than Sporting Clay Stations, Wobble and Five Stand. Shooting of animals and birds is strictly forbidden while on Bermont Shooting Club, Inc property. Only one shooter at a time. All other shooters/spectators must stay in a safe area away from shooter. All Shooters and Spectators MUST wear EYE and EAR PROTECTION at ALL TIMES. A maximum of 2 shells in a shotgun at any one time. No shells larger than 12 gauge with 3 drams of powder and shot size larger than 7 ½. In case of misfire, keep gun pointed down range for 30 seconds with the action closed before trying to correct the situation. ABSOLUTELY NO ALCOHOLIC beverages or NARCOTICS or other prohibited substances allowed on range at any time. Anyone appearing to be under the influence will not be allowed on the course. Children must be supervised by an adult at all times. Children under 15 will not be allowed to use golf carts. No one is allowed in restricted areas off the pathways at any time. Please. No littering. Place empty shells in the bins provided: empty hulls on the ground are property of the club. NEVER attempt to repair any machine/equipment. Call the office at 941-575-4500 so a member of the staff can make the repair.

5. Failure to follow the rules and any unsafe or un-sportsman like conduct will result in removal from the property.

REGLAS DE TIRO PARA BERMONT SHOOTING CLUB, INC

Las reglas de disparo se aplicarán estrictamente. Cualquier persona que dispara o sea espectador en el Bermont Shooting Club, Inc debe tener una copia firmada y atestiguada de estas reglas y la liberación en el expediente. El rodaje o la inspección sin un formulario de consentimiento firmado serán considerados para dar su consentimiento a sus términos y condiciones con o sin firma. Los tiradores y espectadores que no hayan utilizado previamente la instalación deben identificar ese hecho en su visita inicial al Club. Lo siguiente se aplica a todos los tiradores y a los que firman en nombre de menores, colectivamente, "participantes".

- 1. El participante (ya sea menor de edad con su padre, tutor o adulto) por la presente asume toda la responsabilidad y el riesgo de lesiones corporales, muerte o daños a la propiedad debido a la negligencia de los disparos (como se identifica a continuación) o de otra manera en o en la propiedad de BSCI para cualquier propósito. El infrascrito reconoce y entiende que hay riesgos y peligros asociados con la participación o la observación de deportes de tiro que podrían causar lesiones corporales graves, discapacidad y la muerte. Además, los riesgos y peligros pueden ser causados por el fracaso negligente de disparos y otros. Todos los riesgos asociados con la participación en el evento/y o la entrada se asumen no obstante.
- 2. El participante (ya sea menor con padre o tutor o adulto) libera, renuncia, descarga y pacta no demandar a las liberaciones ', asociaciones, organizaciones sancionadoras (o cualquier afiliado de los mismos) operadores de rango, funcionarios, propietarios, arrendatarios y arrendatarios de locales, y para cada uno de ellos, sus oficiales, agentes y empleados (todo con el propósito aquí mencionado como ("RELEASEES") de toda responsabilidad hacia nosotros mismos, los firmantes, nuestros representantes personales, cesionarios, herederos y parientes próximos por cualquiera y todas las reclamaciones, demandas de pérdidas o daños del participante (ya sea por menor de edad por el padre o tutor o adulto) a causa de cualquier lesión, incluyendo, pero no limitado a la muerte o lesión del participante (si es menor de edad por el padre o tutor o adulto) todo lo cual es causado o al leged a ser causada por la negligencia de los RELEASEES o de otra manera.
- 3. El participante (ya sea menor de edad por el padre o tutor o adulto) por la presente acepta indemnizar a liberar y mantener indemne, los lanzamientos y cada uno de ellos de cualquier pérdida, responsabilidad, daño o costo que puedan ocurrir debido, de cualquier manera o grado a la presencia del padre/ tutor o el participante (si es menor de edad por padre o tutor o adulto) o relacionado de alguna manera con la participación o presencia en los locales y si es causada por negligencia de las versiones o de otra manera. El padre y/o tutor reconocen y acuerdan que están ejecutando este acuerdo de exención y liberación de responsabilidad e indemnización en nombre del participante.

4. Esta exención de responsabilidad, Asunción de riesgo y el acuerdo de indemnización se extiende a todos los actos de negligencia por parte de los RELEASEES. INCLUIDAS las operaciones de rescate por negligencia y está destinada a ser tan amplia e inclusiva como lo permitan las leves de Florida y que si alguna parte de la misma se considera inválida. Se acuerda que, a pesar de ello, el saldo continuará en pleno vigor y efecto jurídico. El participante también acuerda seguir todas las reglas, así como cualquier regla actualizada o cambiada que pueda ser publicada sobre la propiedad. Piense en "seguridad primero y siempre". No habrá armas cargadas desde y hacia las estaciones de tiro. Las pistolas solo se pueden cargar en la estación de tiro después de que la zona esté segura. Mantenga las pistolas cargadas apuntando en un lugar seguro en todo momento. Cuando no esté en una estación de tiro, su arma debe llevarse descargada y con la acción abierta en todo momento. No habrá disparos en ningún otro lugar en Bermont Shooting Club, Inc aparte de las estaciones Sporting Clay, Wobble y Five stand. El rodaje de animales y aves está estrictamente prohibido mientras que en la propiedad de Bermont Shooting Club, Inc. Sólo un tirador a la vez. Todos los demás tiradores/espectadores deben permanecer en un área segura lejos del tirador. Todos los tiradores y espectadores deben llevar la protección ocular y del oído en todo momento. Un máximo de 2 proyectiles en una escopeta al mismo tiempo. No hay proyectiles más grandes que el calibre 12 con 3 DRAM de polvo y tamaño de disparo mayor que 7 1/2. En caso de error de disparo, mantenga el cañón apuntando hacia abajo durante 30 segundos con la acción cerrada antes de intentar corregir la situación. NO se permiten bebidas alcohólicas ni estupefacientes u otras sustancias prohibidas en el alcance en cualquier momento. Cualquiera que parezca estar bajo la influencia no será permitido en el curso. Los niños deben ser supervisados por un adulto en todo momento. A los niños menores de 15 años no se les permitirá usar carritos de golf. No se permite a nadie en áreas restringidas de las vías en cualquier momento. Por favor. No hay basura. Coloque los proyectiles vacíos en los contenedores provistos: los cascos vacíos en el suelo son propiedad del Club. Nunca intente reparar ninguna máquina/equipo. Llame a la oficina en 941-575-4500 para que un miembro del personal puede hacer la reparación.

El incumplimiento de las reglas y cualquier acto inseguro como conducta resultará en la eliminación de la propiedad.
