SESSION DESCRIPTIONS

Welcome and Keynote: An overview of the environmental, legal and labor landscape | Buddy Cox, Bradley and Richard Lehr, Lehr Middlebrooks Vreeland and Thompson

Attorney's Buddy Cox and Richard Lehr are leaders and well known for their experience and knowledge in their field. Buddy Cox, a shareholder with Bradley will give a brief overview of the legal news and analysis on environmental issues happening now that could have a potential effect on manufacturers. Richard Lehr, a shareholder with Lehr Middlebrooks Vreeland & Thompson will give a broad update on the many new labor and employee laws in the post covid-era.

Community Partnerships | Donna Jackson, International Paper

Manufacturers serve their communities and it's crucial that they build strategic community partnerships. Building positive and productive relationships with these organizations can be tremendously beneficial to the facility. Giving back to a community where employees live and work can help boost employee morale and further hold their status as an indispensable member of the community. In this workshop, Donna Jackson will give an overview of the programs implemented at International Paper, the challenges she has faced and how to avoid common pitfalls.

Communication and Color Dynamics | Mike Jackson, Troy CE&O

Using a color dynamics assessment, CE&O trainer Michael Jackson will assist you in identifying your communication strengths, identify areas for growth, and also help you identify how your communication style is perceived by others. Once you understand your preferred style, you can begin to identify the various styles of others as well and lead them in the most effective manner. **EPA Update | Caroline Freeman, Air and Radiation Division Director** This session will discuss current and future EPA initiatives with an emphasis on activities affecting EPA Region IV states (southern states).

How the Medical Marijuana Bill Affects Employers | Carin Burford and Tae Phillips, Shareholders, Ogletree Deakins

Marijuana legalization has been a hot topic in Alabama. On May 17, Governor Kay Ivey signed legislation legalizing medical cannabis. In this session, Carin Burford and Tae Phillips discuss the impacts and challenges it has on employers, including compliance with the marijuana statutes themselves, underlying disability issues with medical marijuana and safety concerns.

ADEM Update | Lance LeFleur, ADEM

Director LeFleur will discuss current environmental issues in Alabama, including relations with EPA, new rules, staffing, finances and trouble spots.

The Future of Safety | Don Elswick, UA SafeState

As the workplace, the workforce and work itself changes, the Environmental, Safety and Occupational and Health (ESOH) field must expand its focus to include existing and new hazards. Moving forward, consideration for how to protect the health and well-being of a diverse workforce is crucial. As we see new work arrangements, we must also consider the need to understand and mitigate safety issues.

OSHA Update | Daniel Fithian, OHST, Compliance Officer

In this session safety professionals will hear directly from a compliance officer with OSHA about upcoming changes, where to find changes and an update on a COVID temporary standard for business and industry.

Legal and Labor Update: Vaccine Mandates | Whitney Brown, Lehr Middlebrooks Vreeland and Thompson

The past year has presented the manufacturing industry with a variety of changes that presented both challenges and opportunities specifically for the Human Resources department. This session will address the particular complexities of the Biden Administration's Federal Vaccine Mandate for large employers, the mounting push back from conservative state leaders, and how Alabama businesses should be preparing for the future.

Climate Change | Dr. John Christy, Distinguished Professor, Atmospheric and Earth Sciences, Interim VP Research and Economic Development, Director, Earth System Science Center, Alabama State Climatologist, The University of Alabama in Huntsville

This lecture will provide information on the historical record of Alabama's climate and how its climate variables have fluctuated. This session will examine some of the more popular claims about climate change due to human emissions of greenhouse gases.

Engaging Millennials | Michael Reaves and Tim Croley, Alabama Technology Network

Are you in the process of training millennials? What is the preferred method of instruction for millennials? Do any of your associates think safety training is boring? This session will demonstrate a no-cost or low-cost approach to engaging millennials and at the same time take some of the boring out of safety training while also making the subject of safety training more appealing to that segment of the workforce.




Active Shooter Training Special Agent Steve Johnson, Alabama Law Enforcement Agency (ALEA)


In this session, Special Agent Steve Johnson with ALEA provides training for how to best respond to an active shooter situation, how to call for help and what to do once law enforcement arrives.
