6:03 ELECTION AND TERM - The Directors and Officers shall be elected by the Members at a general meeting of the Chamber, such meeting to be held no later than October 31st in any given year. The Directors and Officers so elected shall hold office for two years commencing January 1st, or until such time as their successors are elected, with these exceptions:

- The Second Vice-Chair (Officer) shall be elected for a one (1) year term.
- The First Vice-Chair shall be elected for a two (2) year term, and shall assume the role of Chair in the second year.

To be eligible for the position of Director, an individual shall represent a Business, or, non government organization or institution whose primary purpose is to serve business, located within the City of St. Albert and District, that is a Member in good standing of the Chamber for a minimum of one year, and shall not be an individual elected to hold public office.

To be eligible for the position of Officer, an individual shall meet the criteria for eligibility as a Director, and shall have served as a Director for at least one year.

All such elections shall be conducted by way of secret ballot unless acclaimed.
