Ottawa Board of Trade Announces New Board of Directors and Executive Committee

OTTAWA, October 2, 2020 – The Ottawa Board of Trade has announced its new Board of Directors and Executive Committee including Ian Sherman elected for a second term as Chair of the Board. Last night at a virtual meeting of the members, the board hosted its 163rd annual general meeting with close to 100 members and guests in attendance. The agenda included presentations of year-end reports, bylaw amendments, election of directors, opening remarks from City of Ottawa Mayor, His Worship Jim Watson and a keynote by the President & CEO of the Canadian Chamber of Commerce, Hon. Perrin Beatty. Immediately following the AGM, the new board elected the Executive Committee for 2020/2021.
