

Summary of Measures: Step 3 of the *Roadmap to Reopen*

CONTEXT | COVID-19 Roadmap to Reopen

- On May 20, 2021, the government released its [Roadmap to Reopen](#), a three-step plan to safely reopen the province and lift public health measures based on the provincewide vaccination rate and improvements in key public health and health care indicators.
- The *Roadmap to Reopen* outlines three steps to easing public health measures.
- The province is scheduled to remain in each step for at least 21 days to evaluate any impacts on key public health and health system indicators. If at the end of the 21 days vaccination thresholds have been met, ***along with other key public health and health system indicators***, then the province will move to the next Step.
- The following slides provide an overview of the public health and workplace safety measures in Step 3.

PRINCIPLES | COVID-19 Roadmap to Reopen



The principles for determining what is permitted in each step are as follows:


STEP 1

Resuming outdoor activities where risk of transmission is lower and limited indoor settings with restrictions



STEP 2

Further expanding outdoor activities and resuming limited indoor services with small numbers of people and with face coverings being worn



STEP 3

Expanding access to indoor settings, with restrictions, including where there are larger numbers of people and where face coverings can't always be worn

Summary of Measures in Step 3 of the Roadmap to Reopen

The following are some requirements that apply to individuals.

Individual Requirements	
Face coverings or masks	<ul style="list-style-type: none">• Required when:<ul style="list-style-type: none">○ Indoors in a business or organization○ Attending an indoor organized public event and are within two metres of another person who is not a part of the same household• The face covering or mask must cover the mouth, nose and chin• Limited exceptions apply
Physical distancing	<ul style="list-style-type: none">• Required when:<ul style="list-style-type: none">○ Indoors at a business or facility that is open to the public○ Attending an indoor organized public event○ Limited exceptions apply, including for members of the same household and caregivers, or when necessary to be closer to complete a transaction or receive a service, if a face covering or mask is worn

Summary of Measures in Step 3 of the Roadmap to Reopen

General Compliance Requirements	
Instructions from Public Health Officers	<ul style="list-style-type: none"> Businesses and organizations must comply with the advice, recommendations and instructions of public health officials, including related to physical distancing, cleaning or disinfecting and screening
Screening	<ul style="list-style-type: none"> Active screening of workers required Passive screening of patrons required (i.e., posting signs at all entrances in a conspicuous location that informs individuals on how to screen themselves for COVID-19 prior to entry) Active screening of patrons required in certain settings (see following slides)
Face coverings and masks	<ul style="list-style-type: none"> Any person in an indoor area of a business or organization or a vehicle that is a part of the business or organization must wear a mask or face covering that covers their mouth, nose or chin, with limited exceptions Not required for workers who are in an area that is not accessible to the public and are able to maintain physical distancing of 2 metres
Requirements when workers eat or drink	<ul style="list-style-type: none"> Physical distancing or a barrier is required indoors when workers remove face coverings to eat or drink

Capacity	<ul style="list-style-type: none"> Limited to the number of people that can maintain physical distancing of 2 metres Other capacity limits apply for certain businesses (see following slides); O. Reg 364/20 also specifies how these additional capacity limits are to be calculated
Line-ups and congregations outdoors	<ul style="list-style-type: none"> Patrons outside a business or place that is open must be managed to ensure they maintain a physical distance of 2 metres
Line-ups indoors	<ul style="list-style-type: none"> Patrons in line ups inside a business or place that is open must be managed to ensure they maintain a physical distance of 2 metres and wear a face covering or mask
Cleaning and disinfecting	<ul style="list-style-type: none"> Equipment, washrooms, locker rooms, change rooms, showers must be cleaned and disinfected as frequently as is necessary to maintain a sanitary condition
Personal protective equipment	<ul style="list-style-type: none"> Personal protective equipment for the eyes, nose and mouth is required for persons providing services if they are required, in the course of providing services, to come within 2 metres of a person who is not wearing a face covering or mask indoors and are not separated by a barrier
Safety plans	<ul style="list-style-type: none"> Safety plans must be prepared, posted in a conspicuous location, and made available upon request Some businesses, places and events have additional requirements that need to be included in their safety plan (see following slides)

Live entertainment	<ul style="list-style-type: none">• Performers must have 2 metres distance or barrier from the audience
Roofs, canopies, tents, or awnings in outdoor spaces	<ul style="list-style-type: none">• If a roof, canopy, tent, awning or other element is used in an outdoor area, it must have at least two full sides, or one full side and the roof, open to the outdoors and unobstructed

Personal care services	<ul style="list-style-type: none"> • Open with capacity limited to the number of people that can maintain physical distancing of 2 metres, including: <ul style="list-style-type: none"> ○ Hair salons and barbershops ○ Manicure and pedicure salons ○ Aesthetician services, piercing services, tanning salons, and spas ○ Tattoo studios ○ Sensory deprivation pods ○ Other personal care services relating to the hair or body • Maximum capacity must be posted • Appointments required • Businesses must record the name and contact information of every person seeking a service (as per O. Reg. 136/18: Personal Service Settings) and actively screen individuals • People who provide personal care services in the business must wear appropriate personal protective equipment • Oxygen bars closed

Teaching and instruction	<ul style="list-style-type: none"> • Open indoors and outdoors • Indoor capacity limited to number of people that can maintain physical distancing of 2 metres up to 50% capacity of the space or 1,000 students, whichever is less • Outdoor capacity cannot exceed 75% capacity of the instructional space or 15,000 persons, whichever is less • Business must record the name and contact information of every student who attends the in-person teaching and instruction and actively screen students • The instructional space must be operated to enable students to maintain a physical distance of 2 metres, except where necessary for teaching and instruction that cannot be effectively provided if physical distancing is maintained
Tour and guide services	<ul style="list-style-type: none"> • Includes: <ul style="list-style-type: none"> ○ Guided hunting trips ○ Tastings and tours for wineries, breweries and distilleries ○ Fishing charters ○ Trail riding tours, walking tours and bicycle tours • Open indoors and outdoors • The number of patrons on a tour must be limited to the number that can maintain a physical distance of 2 metres • Businesses must record the name and contact information of every member of the public • Businesses must actively screen employees and performers

Commercial film and TV production	<ul style="list-style-type: none"> • Open • Capacity for studio audiences is 50% to a maximum of 1,000 people; maximum capacity must be posted • Additional restrictions, including operating in accordance with the guidance document titled “Film and television industry health and safety during COVID-19”

Retail	<ul style="list-style-type: none"> • Capacity limited to the number that can maintain a physical distance of 2 metres • Maximum capacity must be posted • If patrons are permitted to test drive any vehicles, boats or watercraft, they must be actively screened and wear a face covering or mask • Specialty vape stores cannot permit an electronic cigarette to be used for the purpose of sampling a vapour product in the store
Malls	<ul style="list-style-type: none"> • Open • No loitering • The number of members of the public in the shopping mall at any one time must not exceed the total capacity determined by taking the sum of the capacities of every business in the mall.
Photography studios and services	<ul style="list-style-type: none"> • Open • Indoor capacity limited to the number of people that can maintain a physical distance of 2 metres; maximum capacity must be posted • Patrons indoors must be actively screened

Emergency Orders Under the Emergency Management and Civil Protection Act (EMCPA)

- The third provincial emergency declared on April 7, 2021 under s 7.0.1 of the *Emergency Management and Civil Protection Act* (EMPCA) ended on June 2, 2021.
- There are currently 3 Emergency Orders (EOs) in effect that were made under s. 7.0.2(4) of the EMCPA. EOs made under this section may be extended for up to 14 days at a time, by order of the LGIC.
- The following orders have been extended until July 28, 2021:
 - O. Reg. 305/21 (Regulated Health Professionals)
 - O. Reg. 55/21 (Compliance Orders for Retirement Homes)
 - O. Reg. 8/21 (Enforcement of COVID-19 Measures)

Orders Under the Reopening Ontario (A Flexible Response to COVID-19) Act, 2020 (ROA)

- The expiry date for the 29 orders in effect under the *Reopening Ontario (A Flexible Response to COVID-19) Act, 2020* (ROA) is currently July 19, 2021 and they may be extended for up to 30 days at a time, by order of the LGIC.
