Thank you for your interest in the Flagler Public Leadership Institute (FPLI), a free candidate education program of the Flagler County Chamber of Commerce.

Flagler County has made great progress over the past few years creating a healthier business climate and supporting economic development. We are fortunate to have elected officials who understand what it takes to keep moving in the right direction; however, to ensure we keep following the right path, our community needs to identify, cultivate and encourage the <u>next</u> generation of public leaders.
