


award went to Dollar General Distribution Center; and their Fulton County award went to CG Roxane LLC.

Letter from the President

On January 21st, Governor Andrew Cuomo released his proposed FTY 2021 Budget, and although there were not many surprises based on what he stated in his earlier "State of the State" message, there are concerns for businesses located in New York State.

Without getting into detail, I will list just a few that will be on the Chamber's radar:

- The Governor is proposing a mandated paid or unpaid requirement that all employers in the State provide certain levels of sick leave for their employees. Depending on the number of employees, this mandate will be paid or unpaid, but job protected.

- There is a provision to ban the sale and use of single-use polystyrene food packaging and other loose packing material, which could impose a hardship on both the restaurant industry as well as manufacturers and shippers situated in the state.

- A provision would ban or severely restrict the sale of most flavored tobacco and vaping products.

- A provision legalizes and authorizes the sale of adult use marijuana within New York.

- There is a proposed of \$3 billion "Restore Mother Nature" environmental bond act.
- A proposal would expand the prevailing wage requirement on public and private development projects within the state. Although this is less broad and onerous than last year's proposal, and does contain certain exemptions, there are still concerns for business.

Optimistically, despite a \$6+ billion deficit, the budget contains no new or increased revenue measures (tax proposals), in fact it proposes reductions in small business taxes for farmers and sole proprietors, and beneficial adjustments to the corporate franchise tax.

Also, there will be a "Medicaid Redesign Team" created to make recommendations to address Medicaid overspending, but as always, the devil will be in the details.

The Chamber will continue to monitor what happens in Albany throughout the legislative session, and the Chamber's Governmental Affairs Committee will keep our members informed, and be proactive in addressing the needs of the business community in the Fulton Montgomery Region, as well as throughout New York State.



Littauer CEO Set to Retire in October

Nathan Littauer Hospital & Nursing Home President & CEO, Laurence E. Kelly, will retire effective October 2, after a successful administrative health care career spanning 41 years; 19 of them at the helm of the Gloversville-based hospital.

“It has been an absolute pleasure,” Kelly says. “It has been the privilege of a lifetime to serve the Gloversville community and this region.”

An announcement of his retirement said, “Kelly has led Littauer during a period of tremendous growth and financial stability. The hospital’s total net assets increased nearly sevenfold from \$13.3 million in 2001; when Kelly began as CEO to \$90 million in 2019. This period was also marked by an increase in jobs. In 2001, the hospital had 656.5 full-time equivalents (FTEs). By 2019, that number had grown to 807.5. Littauer’s footprint has expanded as well, adding eight primary care centers, spanning a total of 52 square miles within the region. Kelly explained, “I think we have achieved these milestones because of two factors: I work with a fearless, creative team. Because of the employees here, I enjoy coming to work each day. I really like my colleagues. That makes a huge difference. The second piece is that we have invested our positive operating margin back into our hospital. In essence, we

have paid ourselves first. I think it has worked. With a positive operating budget, we have saved for our future and simultaneously secured sophisticated technology and improved access to care.”

“Larry has great insight and vision in the health care industry,” said Gregory Truckenmiller, Ph.D., Chair of the Littauer Board of Directors. “He has been adaptable amidst constant change in the industry and had the courage to make decisions others had difficulty with. It is because he took those risks that Littauer has remained independent, committed to quality, and achieved 18 consecutive years operating in the black while many rural hospitals around the country are struggling or even closing.”

“Medical staff who have worked at other hospitals often observe that the equipment we provide our surgeons and radiologists is much better than what they have used at other, often larger hospitals,” said Frederick Goldberg, M.D., Littauer Vice President of Medical Affairs and Chief Medical Officer. “Under his guidance we have been able to offer minimally invasive spine surgery; advanced diagnostic imaging technologies; critical care telemedicine;

state-of-the-art maternity facilities; and a dialysis center that is attached to the hospital and nursing home.

These medical and technological advancements mean better care for our patients,” Dr. Goldberg adds. “It helps recruit talented physicians to the area. None of this would have been possible without the vision and leadership of Mr. Kelly.”

“Influential leaders are a rare breed,” said Stephanie Fishel, Littauer Chief Nursing Officer. “Larry Kelly is an influential leader. He mentors the strengths of his team members and sets us up to succeed. Under his leadership, our nursing care has evolved, strengthening our foundation in patient safety,

clinical skills, and more. Because of him, our patients experience state-of-the-art technology and expert care-givers right here in our rural community.”

Kelly added, “My goal has always been to build an independent organization that can quickly respond to the unique needs of this community. We also needed to stand on solid footing. I wanted to build a hospital for this generation and the next.”

The Littauer Board of Directors will begin work immediately to recruit Kelly’s successor. Littauer staff, volunteers, and others will celebrate his contributions to the organization and community at an event in September. Details will be forthcoming.

A fund is being established at the Nathan Littauer Hospital Foundation to honor his years of service and leadership. More information on the details of that fund will be shared

as soon as possible.

Kelly noted, “I am grateful for the visionary leadership of Littauer board members past and present, the talented and dedicated team of professionals with whom I’ve had the pleasure of working with, the selfless donors and volunteers who support the hospital with such enthusiasm, and the people who consistently choose us for their health care. I will leave Littauer with a great sense of pride, knowing what we’ve accomplished together is meaningful and will matter to this community for generations to come.”

“There never is a perfect time to leave,” Kelly said. “But I wanted to go out on a high-note without worrying about our future. This feels like the right time.” Truckenmiller agrees. “He will be missed, but he has positioned us perfectly for Littauer’s next chapter. On behalf of a grateful board of directors, we are committed to making sure his legacy will continue.”

HFM BOCES To Reconfigure PTECH Programs To Enhance Efficiencies

HFM BOCES will implement adjustments to its Pathways in Technology Early College High Schools (PTECHs) for the 2020-21 school year.

The changes, developed in collaboration with the superintendents of HFM BOCES component school districts, are designed to strengthen all of the programs and support every student's path to high school and college completion.

In order to leverage efficiencies and opportunities for cooperation among the schools, the three programs will be co-located by grade-level. This reconfiguration will enhance and increase opportunities for students and ensures that all of the degree pathways currently offered to students remain viable.

Presently there are three separate PTECH schools in the region. The HFM PTECH at Jansen Avenue and the Foothills PTECH at Johnstown High School are aligned with degrees offered by Ful-

ton-Montgomery Community College (FMCC). The Agriculture PTECH at D.H. Robbins School in St. Johnsville places students on a path toward degrees conferred by SUNY Cobleskill. The desired outcome for students in each program includes high school completion and the attainment of an associates' degree within six years of enrollment in ninth grade.


Starting in July 2020, the PTECHS of HFM BOCES will be organized into three "Pathway Clusters": Pathways in Business and Advanced Manufacturing; Pathways in Agriculture; and Pathways in Medical/Health Sciences and Computer Science.

Grades 9 and 10 for all three pathway clusters will be located at the Jansen Avenue School in Johnstown. Grade 11 students in each pathway cluster will transition to HFM BOCES' Main Campus and FMCC, which are directly connected.

Beginning in Grade 12, students enrolled in the Agriculture Pathways will attend SUNY Cobleskill and continue for two additional years or until they complete the requirements for an associate degree.

Similarly, Grade 12 students enrolled in the Business and Advanced Manufacturing Pathways and the Medical/Health Science and Computer Science Pathways will begin to attend FMCC and continue for two additional years or until they complete the requirements for an associate degree.

"The motivation for implementing this structure is simple: provide the strongest possible path to high school and college completion to our students," HFM BOCES District Superintendent David Ziskin said. "In addition to the benefits to students, streamlining our early college programs will allow us to operate more efficiently and helps ensure the long-term sustainability of the PTECH model in the HFM region."

New York State Enacts Ban on Salary History Inquiries by Employers

Effective January 6, 2020, New York State employers are prohibited from orally or in writing seek, request, or require wage or salary history from an applicant for employment, or a current employee, as a condition of being interviewed, or as a condition of continuing to be considered for an offer of employment or being promoted.

The new law does however, allow employers to ask about a candidates' salary history after making a Conditional Offer of Employment to a candidate. Further, the new law does not preclude an applicant for employment from voluntarily disclosing their salary history to a perspective employer.

Cadillac Tax and Other Key ACA Taxes Repealed

The federal spending bill signed into law at the end of 2019 repealed three taxes and fees under the Affordable Care Act (ACA):

- The Cadillac tax
- The medical devices excise tax
- The health insurance providers fee

The Cadillac Tax

The Cadillac tax is a 40% excise tax on high-cost group health coverage. Its effective date was previously delayed several times. This tax is now fully repealed, beginning with the 2020 tax year.

The Medical Devices Excise Tax

The medical devices tax is a 2.3% excise tax on the sales price of certain medical devices. This tax is fully repealed beginning in 2020.

Health Insurance Providers Fee

The health insurance providers fee is an annual fee imposed on the health insurance sector. This fee is repealed beginning with the 2021 calendar year. Employers should be aware of the evolving applicability of existing ACA taxes and fees so they know how the ACA affects their bottom lines.

PCORI Fees Extended for 10 Years

The same spending bill that repealed the Cadillac tax, the medical devices excise tax and the health insurance providers fee reinstated the annual Patient-Centered Outcomes Research Institute (PCORI) fees for the 2020- 2029 fiscal years. As a result, specified health insurance policies and applicable self-insured health plans must continue to pay these fees through 2029.

What Are the PCORI Fees?

The PCORI fees were created to help patients, clinicians, payers and the public make informed health decisions by advancing comparative effectiveness research. Fees paid by health insurance issuers and sponsors of self-insured health plans fund the institute's research, in part.

Who Must Pay the PCORI Fees?

The entity responsible for paying the PCORI fees depends on whether the plan is insured or self-insured.

- For insured health plans, the issuer of the health insurance policy is required to pay the fees.
- For self-insured health plans, the fees are to be paid by the plan sponsor.

What's Next?

PCORI fees are reported and paid annually using IRS Form 720 (Quarterly Federal Excise Tax Return). These fees are due by July 31 of the year following the last day of the plan year. This means that, for plan years ending in 2019, the PCORI fees are due by July 31, 2020.


The float's inclusion in the parade marked the beginning of nationwide celebrations

Reflections of The Elizabeth Cady Stanton Hometown Association's Rose Parade Outwalkers

Representing the suffragists of New York would be impossible for one person. There are simply too many luminaries, not to mention the throngs of unrecognized women who served in suffrage clubs in every county in the state.

Yet there I was in Pasadena, pinning on my banner to represent New York State, accompanied by Bonnie Valachovic, who was representing Montana, for the Pasadena Celebrates 2020 float in the Rose Parade on January first. Joining the other 99 outwalkers behind the 50-foot rose and iris covered float, complete with a eucalyptus leaf covered Statue of Liberty, we were humbled. We were looking forward to shining a light on the hard work of the women and men of previous generations who worked so

selflessly to pass the nineteenth amendment to the United States Constitution, which granted many women the right to vote. The Stealth Bomber flew over, Alicia Keys' "Girl on Fire" blasted from the speakers, and we headed out, left foot first.

But as we marched the five and one half miles of the parade route, something very unexpected happened. The crowd didn't seem to recognize us just as a symbol of history, they saw us as a symbol of hope. The middle-aged man who put his hand over his heart as we passed. The elderly woman nodding her head with tears in her eyes. The teenage boy with both fists pumping in the air. The young women standing and whooping. Our chants changed as we marched from, "Votes for Women!" to "Use your Vote!" and the crowd joined in. In honor of float rider civil rights icon, Do-

lores Huerta, we began, "Si se puede!" Spanish for "Yes we can!" Again the crowd roared back. The energy never stopped, we were waving furiously and high-five-ing hands even through the last block.

As the parade ended, we weren't the same people we were when it started. Those spectator faces - every age, color and gender - nearly one million by most accounts, had empowered us. The suffragists we were honoring were proof that grassroots organizers can make a change. We can't let it stop with them. Those cheers reminded us that there is still work to be done, not just for women, but for equal rights for all. Let this year's Pasadena Celebrates 2020 float kick off a new decade of activism, collaboration, and change, so we can genuinely earn the applause that we so generously received.

Gloversville Seeks Volunteers To Help Plan ‘100in1 Day’

The Gloversville Downtown Development Specialist at The Fulton County Center for Regional Growth seeks volunteers, community groups, businesses and local residents to participate in and join a committee to plan 100in1 Day: Gloversville, set for Saturday, May 2.

100in1 Day is an international movement currently in 60 countries, and acts as a “civic incubator,” where ideas and contributions are generated and validated by active and engaged citizens. According to Gloversville Downtown Development Specialist James Hannahs, “The event is meant to bring people together on one single day to perform 100 (or thereabouts) acts of positivity for their community with as much expression and openness as possible. More broadly, 100in1 Day is meant for every citizen to be unequivocally involved and fearlessly contributive.”

Hannahs said that in 2019, Gloversville debuted as the first city in the United States to successfully launch a 100in1Day event. “It reached all corners of the city with vibrant activities and oceans of volunteers,” he said.

Event organizers said they are now looking for help in the forms of input, time, and support. Volunteers can engage in activities of every size and scope, and virtually anyone can foster an idea that sprouts into an activity. Hannahs said the activities “can be as small as handing out promotional cards in walking ‘hotspots,’ or planting flowers around stop signs and lampposts, or working in conjunction with other volunteers to paint a downtown mural. The possibilities are certainly endless.”

Activities hosted last year included community-wide spring cleanups, car washes, free fitness classes, craft workshops, food drives, free

community concerts, dance competitions, item giveaways, sporting events and tournaments, art shows, and more.

Hannahs said, “2020 marks a special year for our city’s development, in both our individual communities and our surrounding regions. We are entering the fourth year of our city’s new beginning, and it’s because of your efforts in helping build a better future. We are continuing to show how an active community is the foundation of creating positive and lasting change that echoes for generations. Our children will learn about fostering and nursing community-sourced ideas and their impacts on a city’s successful development ventures. Through your continued hard work, we can help them truly understand the importance of being an active and engaged citizen of the City of Gloversville.”

The planning committee for the event is looking for ea-



ger, enthusiastic, and engaged community members to help plan and execute the day. Hannahs said committee members “can be a business owner, someone who works downtown or anyone in the community who is looking to help us make a positive, lasting impact on our city.”

In-person meetings will be held once per month starting in February and will conclude in May. Some email communication may be necessary thereafter. Hannahs said the group may ask members to help contact possible community groups, musicians, etc. to help fill-in programming for the day and for ancillary logistics.

He said, “We don’t expect participation to require more than two or three hours per month in total.” Committee members do not have to work at the event but are welcome to. There will be a more general call for volunteers for the day as the event draws closer.
