



Last month, we talked about how we will outline some of the Business Council of New York's key initiatives that will promote continued private sector investment, employment and job growth. Workforce Development was the subject matter for our August issue. This month, we will discuss more of the Business Council's Business Advocacy Agenda for 2023:

Address Unemployment Insurance Taxes

Unemployment taxes in New York are paid by employers to fund the state's unemployment insurance (UI) program. This tax is used to pay benefits to unemployed workers who meet the program's eligibility requirements. Unemployment insurance taxes are at an all-time high for many employers, fueled by \$8 billion in federal loans. According to the NYS Labor Department website, the 2023 UI tax rates range from 2.1% to 9.9%, and the total tax rate for new employers is 4.1%. The taxable wage base increased from \$12,000 in 2022 to \$12,300 in 2023. The Business Council believes that the state needs to apply public funds to help repay COVID-based debt, offset the cost of interest on federal loans, and pay the cost of fraudulent and other improper benefit payments. The state should also update technology used to address costly unemployment insurance fraud.

Targeted Tax Incentives

There are opportunities for New York to use targeted tax credits to support achievement of important policy goals. The state should adopt a broad "work opportunity credit" modeled on the federal tax credit, to incentivize the hiring of persons facing barriers to employment or reemployment. The IRS.gov website explains that the federal Work Opportunity Tax Credit (WOTC) is a federal tax credit available to employers for hiring and employing individuals from certain targeted groups who have faced significant barriers to employment. WOTC partners with other workforce programs that incentivize workplace diversity and facilitate access to good jobs for American workers.

The Business Council also believes that the state should adopt a more robust refundable manufacturing investment tax credit, which could be targeted to "green" investments and products. Currently, qualified NYS manufacturers may be eligivle to receive a credit equal to 20% of the real property paid during the tax year on the NYS business property. To be eligible, you must use your property principally for manufacturing, processing, assembling, refining, mining, extracting, farming, agriculture, horticulture, floriculture, viticulture, or commercial fishing (from the tax.ny.gov website). The Business Council thinks that the state should adopt a more robust research and development tax credit that supports investments in both capital and nondepreciable R&D expenses. What's on the docket for the Chamber's Governmental Affairs Committee...

The Chamber's Governmental Affairs Committee has been meeting about 6 times a year or on an as needed basis. They are glad to have now both a representative from Montgomery County Executive Matt Ossenfort's office (Morgan McClary) and a liaison from the Fulton County Board of Supervisors as members. The group is working on putting together a Legislative Breakfast in January of 2024 (tentative) where both counties' state and federal legislators will be invited to give an update on what they are working on, and to speak with our business members. To that end, watch for a **survey** that the committee is planning to send out to Chamber members to see what business issues they are looking to have these representatives discuss. Chamber board member and committee member Mike Schaus from WENT Radio will be the host/ emcee of the event.

As previously mentioned, the Chamber follows the Business Council's advocacy efforts and initiatives on the state level. What they would like to get more involved with is with **elected officials and representatives on the local level in Montgomery and Fulton Counties** to further develop these local relationships with our Chamber-member businesses. One of the ideas they have is to build a comprehensive database of local officials and have them get more involved with the Chamber and on the flip side, have our businesses more involved with advocacy on the local level.

Governmental Affairs David Jankowski wants our members to **keep the Committee in mind when you have advocacy questions or issues**. The Chamber and its Governmental Affairs Committee wants to be your advocate on all of your business advocacy needs. A three-day Short Play Festival that took place in August is just one of several events the <u>Foothills Arts Council</u> has planned for their 2023-2024 season. Cash brings years of past experience on several corporation boards, is a certified public accountant (CPA), and has a wealth of knowledge about the history of arts in Fulton County.

GLOVERSVILLE PALACE DINER CELEBRATES 100 YEARS IN DOWNTOWN GLOVERSVILLE

City renames Spring Street as the new Palace Way On Saturday, August 26, the Sena family, owners of the <u>Gloversville Palace Diner</u> for the last 50 plus years, joined Gloversville Mayor Vince DeSantis and members of the city's Common Council, along with Fulton County Supervisors, and state legislators, to celebrate 100 years of the diner in downtown Gloversville.

Samantha Hall-Saladino, Fulton County Historian, read from a blog post she wrote in 2019 about "The City's Palace" on gloversvillearts.com. In it, she outlined the history of the diner, "It was built by the Jerry O'Mahony Dining Car Company of Bayonne, NJ...Today, there are only



approximately 20 O'Mahony cars still in existence. One of them is the Palace Diner in Gloversville."

"The Palace was shipped by railroad from New Jersey to Fonda, then transported by truck from Fonda to 62 South

Main Street in Gloversville, where it has stood ever since. The original diner was about 40 x 10 feet and looked very much like a railroad car."

"Albert Main owned the Palace from its opening in 1923 until 1937, when his nephew, Carlton G. Clute, took ownership. He was only 21 years old. The building itself underwent some changes throughout its life: an addition was added in 1932, and the interior was remodeled in 1951 with stainless steel appliances and new tile. Many of the

original features and midcentury changes are still visible inside the Palace today. In 1972, Clute sold the Gloversville Palace Diner to Anthony Sena, an employee. Though Anthony passed away in 2014, the Sena family still owns and operates the Palace." Jackie Sena, Anthony's wife, Anthony, Jr. and Diane Sena were all on hand for the event, and had a chance to speak to the crowd, thanking their customers and all who supported the business over the course of their history. After a number of dignitaries



spoke, members of the Sena family (pictured are Jackie and Anthony, Jr. holding the fabric) unveiled the new "Palace Way" sign that now stands next to the diner. Congratulations to the Sena Family and the Palace Diner on this amazing milestone and for continuing to do business in the City of Gloversville for over 100 years!

- n. **YouTube**—if you have a video from a past event or to talk about an upcoming event and would like to share it, it would go here. You have to upload your video to your YouTube channel first, then share the link in the Video URL box

Once you have all the details entered, you can either **Save as Draft** which allows you the option to save your work and come back to complete it, or you can **submit for approval.** This will send your event details to Chamber staff for approval, and once the event is approved it will show on the Chamber website!

MANAGE YOUR EVENTS

- 1. Once you are logged into the Member Information Center (see instructions above), click on Events. In the Events area click Manage Events (see graphic below)
- 2. The Manage Events page is a place you can go to see events you have submitted; it will show pending, current and past events.
- **3.** To make an update to an event, simply click on the event title, make your updates, and submit for approval
- 4. Preview an event by clicking the Preview link under Action
- 5. Copy a past event to save time when creating an event. This will take the details of a past event and populate the fields of the new event page and you only need to update certain information.
