North Central District Health Department regretfully announces three new deaths in Shelby County due to complications from the Novel Coronavirus (COVID-19). Fifty-seven new lab-confirmed cases in Shelby and Spencer Counties; increasing the district case count to 519. Forty-five individuals monitored by North Central District have been released from isolation.

**Shelby County, KY** – Shelby has had three new COVID-19 related deaths, all elderly females with underlying medical conditions; our hearts and prayers go out to their family and friends.

North Central District Health Department has fifty-seven new cases that tested positive for the Novel Coronavirus (COVID-19).

North Central District released forty-five individuals from isolation; thirty-eight from Shelby County, three from Spencer County, two from Trimble County, and two from Henry County who monitored their symptoms and complied with a self-isolation agreement with the Health Department.

"North Central District is working with the Department of Public Health and two congregate settings to mitigate the spread of the virus within those facilities", said Roanya Rice, Public Health Director of NCDHD
