For good and valuable consideration including the acceptance of my/my minor child's entry or participation in the Ladies Kingfish Tournament (LKT) and/or events held at SPI Convention Centre and Sea Ranch II at SouthPoint Marina, the undersigned hereby releases and agrees to hold harmless LKT, SPI Chamber of Commerce, SPI Convention Centre, Sea Ranch II at SouthPoint Marina, owners, management of same and their respective heirs, successors, assigns, officers, directors, employees and agents from and against any damages or claims whatsoever (including, without limitation, claims for personal injury, death or damage to personal property). The undersigned further agrees to indemnify, defend and hold harmless LKT, SPI Chamber of Commerce, SPI Convention Centre, Sea Ranch II at SouthPoint Marina, owners, management of same and their respective heirs, successors, assigns, officers, directors, employees and agents from any claim for personal injury, death or damage to personal property arising in any way out of my/my minor child's entry or participation in the tournament or any of its related activities.

**Polygraph Test Authorization, Release of Liability and Photo Release**
