LOP envisions the future

I enjoy the beginning of the New Year with all the "firsts" that it brings. A highlight of my January each year continues to be meeting the new class members of Leadership Overland Park.

The 2018 class certainly didn't disappoint and I can't wait for you to meet them, too. They are particularly sharp this year, representing so many facets of our community. We have both young and seasoned professionals. We have those who were born and raised in Overland Park, and several who were born outside the U.S., but have chosen Overland Park as their home. This class represents businesses of all sizes and types, from non-profit, to hospitality, to engineering, finance, healthcare and family-owned small business. We have several elected officials, and some who have had several careers, bringing a wealth of experience to the group. The experiences of those who have lived elsewhere in the country, and throughout the world, have elevated the discussions for the group.

This is the 35th class of LOP and, over the years, the steering committee and staff team have worked to improve the program, adding new experiences, class readings and a project to expand opportunities for leadership development and community engagement. The 2017 and 2018 classes began their experiences by reading *The Heart Led Leader: How Living and Leading from the Heart Will Change Your Organiza-tion and Your Life* by Tommy Spaulding. I highly recommend this book (a quick read, by the way) for anyone interested in further developing their own leadership effectiveness and that of their teams. Tommy is an engaging speaker and a to-the-point writer. He is direct when he says, "... leaders and organizations that lead with their hearts are more successful and drive better than those that don't. Love and results are not opposites. They are two sides of the same coin. It is not love or results. It is love-driven results."

Class members discussed their own leadership styles, and explored the book's impact on how they could maximize their own strengths as well as the strengths found in other leadership styles to maximize results. This provided a good foundation for the day's final discussion, a SWOT analysis of Overland Park. Hopefully you've heard from numerous sources about our joint partnership with the City and Visit OP in a visioning project called ForwardOP. As a warm-up, we asked this year's LOP class to think about our community, not just from a traditional Strength/Weakness/Opportunity/Threat standpoint, but to take it a step beyond as prep for the visioning discussion. What strengths are our benchmark? Why do you choose to live here? What is unique? Instead of weakness, what do we need more of, less of in order to be competitive? What are the potential roadblocks inhibiting our success?

It's always interesting to see what makes the list. I won't take space for all the usual suspects, but will mention a few. Of course the quality of our public education system was high on the strengths lists, along with safety, our workforce, access and quality of healthcare, redevelopment in old OP, bike trails and parks. But those who have lived elsewhere reminded the group to not forget the quality of leadership, efficient commute times, cost of living and housing, the access and convenience of grocery stores, and the welcoming culture of our community.

What's missing? Nightlife. More public transit. Walkability, bike paths that connect. Lots of live music to choose from. Other weaknesses: workforce shortages, especially for restaurants and in nursing, healthcare capacity and the ever-present issues


