Study recommends infrastructure to enhance OP Central District

ECONOMIC DEVELOPMENT

OP Central – focused on the College and Metcalf district and surrounding areas – is the business and visitor hub of Overland Park.

The district includes the Overland Park Convention Center, a variety of hotels, several million square feet of office space with an employment base in normal times of more than 30,000, substantial commercial assets, and a growing number of residential units. Yet, all of this is spread over about 1 ½ square miles, separated by large parking lots and extensive green areas typical of large-scale contemporary suburban development.

In 2018, improved connections for pedestrians and bicyclists was identified as a priority in the OP Central Master Plan. This led to the current College and Metcalf Mobility Study sponsored by the City of Overland Park, Overland Park Chamber, Convention Center, and Visit OP, and funded through the Mid-America Regional Council's Planning Sustainable Places program. RDG Planning & Design of Omaha led a consulting team that also included Landworks Studio, Schockey Consulting and BHC.

The College and Metcalf Mobility Study has included extensive community engagement and consultation with a representative steering committee, individual interviews and group stakeholder discussions, a public planning workshop, four open houses, and an online survey.

The process identified six key stakeholder groups:

The light of future generations

MESSAGE FROM OUR PRESIDENT

Recently an icy forecast forced us to take opening day of Leadership Overland Park virtual. What could have been a snoozer of a day on Zoom was the opposite as the class embraced the day, cameras on and energized.

I always look forward to this session, meeting the class, getting to know their personalities, and hearing their take on Overland Park. The agenda includes a community SWOT analysis which is foundational to future sessions.

Not surprisingly, the class's list of Overland Park strengths includes top-ranked schools, parks, neighborhoods, affordable taxes, transportation access, trails and bike paths, abundant quality health care, and public safety. They also noted our public schools' special needs programming, our sense of community and small-town feel, and some specifics like our ability to have basements and new projects like the conversions of former hotels into apartments.

Threats are intensifying as the pandemic's impact lingers. There were concerns about delivering quality education given work-

force challenges due to retirements and retention across all sectors, from bus drivers to the classroom. Other community threats included low housing inventory, supply chain issues, lack of diversity, inflation, labor shortages, limited attainable housing, and polarization created by neighborhood revitalization.

The "Opportunities" discussion brought both optimism and innovation, including mention of the ForwardOP community vision. With calls for creativity and adaptive zoning rules, the group envisioned more housing options, including accessory dwelling units, which are secondary homes or apartments occupying the same lot as a larger, primary residence, often used to provide additional income or to house a family member. They're interested in building complete streets with bike lanes and sidewalks, more public transportation, and are excited about participating in the City's upcoming Comprehensive Plan. They see insufficient resources for mental health and behavioral services, providing opportunities for clinics to focus on these areas as well as dental and vision. They see opportunities to partner with educators to bring more students into health care fields.

OP Central Plan continued ...

The stakeholder groups have different but related interests, united in the need for better multi-modal connectivity, an improved experience, and more centers of activity in OP Central.

In its concepts and recommendations, the plan focuses on five general areas:

- Components that provide a safer, more comfortable, and more attractive environment for people on foot, bike, or other active modes;
- Addressing barriers presented by multi-lane streets and heavy traffic;
- Providing points of interest along the way for all users;
- Wayfinding, bike share, and shuttle service that make the area more usable;
- Aspirational features that create destinations while addressing major challenges.

The study identifies 20 individual projects designed to use the area's unique assets to create a better environment for residents, workers, visitors and customers. Perhaps the most visible would be a lighted pedestrian path separated from the street along the south side of College Boulevard between Metcalf and Nall. This would connect water features and landscaped areas to create a linear park environment that also would include small activity nodes.

Other recommendations include intersection improvements and more visible crossings for pedestrians, new shared use side paths, better connectivity to the Summercrest and Indian Creek trails, private building-to-building connections, enhancements to existing bike lanes and accessibility and site improvements at the Convention Center. Special project ideas include an iconic pedestrian bridge linking all four corners of College and Metcalf, a brooklike water feature along Lamar Avenue, and a multi-leveled park connecting the Aspiria campus to the district north of 115th Street.

The Draft Study will be presented to the City's Committee of the Whole on March 21.






