Key Projects

Hill's Pet Nutrition

relocated its global and U.S. headquarters to the Aspiria campus, bringing 450 new jobs to the community and an investment of \$33.5 million.

The Andersons, an ag

supply chain company, will expand its trading offices to 33,200 square feet of space in CityPlace, adding 100 jobs and retaining 160 with a \$3M capital investment.

IMA Financial Group, an integrated financial services company, will invest \$7.3M to expand its Overland Park offices to a new, 44,000-square-foot space in CityPlace, retaining 120 jobs and adding 100.

Public Policy and Business Advocacy

- Chamber delegation traveled to Washington, D.C., to discuss critical business issues with federal elected representatives and other national leaders
- Advocated in Topeka, providing legislative testimony on business and community issues, including apprenticeships, housing, economic development, childcare, workforce and business fees
- Passed legislation (HB 2292) promoting workforce development through expanded apprenticeship opportunities and incentives to increase engineering graduates, educators and skilled workers
- Supported legislation (SB 164) creating tax credits for childcare workers to assist in increasing much-needed childcare capacity in Johnson County
- Defeated legislation (SB 315) that would have trumped employers' right to require vaccinations in their workplaces
- Supported workforce availability by backing legislation to increase housing options (SB 34) and restore driving privileges for minor traffic offenses (SB 2)
- Helped local small businesses navigate government systems and obtain required licenses to begin operations in Overland Park





Talent Initiatives

- Heightened concentration on workforce development, adding two new positions focused on the challenges of talent recruitment and retention
- Created Talent Council, which chose TIP Strategies, an economic development and workforce consultant, to conduct a comprehensive local labor shed analysis of top employment segments, occupational pathways, skill gaps and workforce assets (completion mid-2024)
- Fostered partnerships with public schools and higher education
- Provided rapid response reemployment resources for those impacted by Yellow's layoff announcement: job fair, resource workshop and 1:1 job assistance

Entrepreneurial Initiatives

- In conjunction with the OP Chamber Foundation, hosted first cohort of the National League of Cities Kauffman FastTrac program
- Sponsored Growth through Action, Measurement and Engagement (GAME) program for second-stage entrepreneurs in partnership with the Kansas Small Business Development Center at JCCC
- Co-hosted 1 Million Cups entrepreneurial networking events
