Here are some highlights from the Vice Chairs' reports:

Business Development Committee (BDC) is led by Marty Martin with B.L. Harbert International. Marty's plans for 2022 are:

- Re-imagine the current monthly Business Development Committee meeting to ensure that they are a productive use of the time of those attending and presenting.
 Consider moving to more of a quarterly meeting vs. a monthly meeting.
- Along with potential changes to the timing and format of the BDC meetings, work towards making the BDC a more active committee vs. a passive committee with committee members being engaged and working towards achievement of the committee goals.

- Continue the process of surveying our membership to explore their needs and how the Chamber could help them meet those needs.
- Present a series of seminars/learning sessions on topics that are relevant and helpful to the membership of the Chamber. This will begin with a session in February about network and computer security, with future meetings scheduled as we progress through the year. In particular we want to assist members in technology related topics as this is an area that seems to have a broad impact on Chamber membership.

The Programming Committee is headed by Linda Parker, Dream Vacations. Speakers from both within Vestavia Hills and from our local area have been lined up for the luncheon meetings held on the 2nd Tuesday of each month. Topics include economic development, education, and events that have both an economic impact and entertainment aspect. Every year we look forward to hearing from our local leaders on the state of the schools and the city.

Clabe Dobbs, Progress Bank, leads the Community Affairs Committee to plan, promote and execute events that appeal to both Chamber members and the community at large. These events include well-known and loved community events, including the Mayor's Prayer Breakfast, I Love America Day and Helping Hands in the Hills that give our members an opportunity to sponsor and promote their services while creating a fun event for all attendees that fosters unity and civic pride.

Keri Bates, Rocky Ridge Drug Co. leads our Membership Development Committee to Recruit, Retain and Engage in 2022. The emphasis is on bringing together members at monthly luncheons and community events and growing membership for the benefit of us all. The "Refer and Win" program continues with a drawing for \$250 prize each quarter from names of members who have referred a new member. Other activities that Engage include Save a Seat, Write a Note, Be Informed and Drop By. Drop By is when a board member Drops By a business to thank them for being a member or encourage them to join the Chamber. The Ambassadors support Membership Development by assisting with communications and attending luncheon, ribbon cuttings and facilitating introductions.

The Public Education Committee lead by Rachel Patterson is the liaison between the Chamber and the school system. The recognition for the businesses who participate in PIE goes far beyond the awards and photos at the monthly luncheon as it enriches the educational experiences of students with articles in school newsletters and at school events. This committee also connects the Chamber to the City Youth Connection (CYC) and to the PTO Council members.

In addition, **Donnie Dobbins is leading the Chamber Strategic Plan for 2022**. The Strategic Plan was developed in late 2019 as a multi-year plan for the benefit of the entire community and led by the Chamber. Toni, a long-time Vestavia Hills resident, served her country in the United States Army Reserve for four years. From there, she earned her Bachelor of Science in Nursing at UAB, graduating cum laude, and embarked on a nursing career. She received the "Outstanding Student Award" in community health nursing, which laid thefoundation for what would later become Mercy Deliverance Ministries. Toni had a growing concern about communities in the Birmingham area and beyond where people needed health care and food, as well as a path out of poverty. The mission of Mercy Deliverance Ministries aims to break cycles of poverty through the delivery of fresh food and produce, healthcare and education. Toni's entire family is involved – husband, Tim, and their three daughters, LaTrisha, Hannah and Angelica.

Karen Odle settled in Vestavia Hills as a young professional. Her UAB degree in Management Information Systems, along with her extensive work experience at Bellsouth/AT&T, provided the foundation for her to work as a freelance consultant for large companies throughout the area. After marriage to Steve Odle and the birth of their two children, Erin and Tyler, Karen became heavily involved as a school volunteer and was tapped for leadership positions, including PTA president at Vestavia Hills Elementary West and president of the Vestavia Hills PTA Council. In 2001, she was appointed to the Vestavia Hills Board of Education, where she served five years, including a year as president. In 2002, Karen accepted the job of Vestavia Hills Chamber of Commerce president, realizing that a strong business community was an important component of a strong city. During her tenure, the Chamber has grown from 296 members to 1,102, as of January 2022, the largest Chamber in Jefferson County. After almost two decades as Chamber president, she will retire in late April, looking forward to spending more time with her family and especially her grandchildren.
