

fter finishing high school in Montgomery, Alabama, Ashley Curry obtained an undergraduate degree in Industrial Management from the University of Alabama and an MBA from the University of South Carolina. His professional career began with Milliken & Company of Spartanburg, SC, followed by a 25 year career as a Special Agent with the Federal Bureau of Investigation. He served the Tampa division for two years then was transferred to Birmingham in 1980 where he remained until his retirement in 2003. #### SELECTING AND ELECTION OF DIRECTORS AND OFFICERS

#### Article IV - Section 2

A. <u>Nominating Committee</u>: At the regular September meeting of the Board, the President shall appoint, subject to approval by the Board, a Nominating Committee consisting of three (3) members of the Chamber. The Executive Director shall serve in an advisory capacity to the Nominating Committee. The President shall designate the Chair of the Nominating Committee.

The Nominating Committee shall present to the Board for approval prior to October 31, a slate of candidates to serve as Directors and Officers of the Chamber for the following year. Each candidate must be a Member in good standing and must have agreed to accept the expected responsibilities. No Member who has served two consecutive years as a Director is eligible to be a Director for a third consecutive year. A period of one (1) year must elapse before eligibility is restored. The Chair of the Nominating Committee shall strive to notify those Directors who are not eligible for reappointment pursuant to this term limit.

- B. <u>Publication of Nominations</u>: Within ten (10) days of receipt of the report of the Nominating Committee, the President shall give Notice to the general membership of the names of persons nominated as candidates for Directors and Officers and the right of petition as contemplated in these Bylaws.
- C. <u>Nomination by Petition</u>: Additional names of candidates for Directors and Officers may be nominated by a petition bearing the genuine signatures of at least fifteen (15) Members of the Chamber. Such petition shall be submitted to the presiding President within ten (10) days after Notice has been given of the original nomination as contemplated in Article IV(2)(B). The determination of the Board as to whether the petition(s) complies with these Bylaws for consideration shall be final.
- D. <u>Determination</u>: If no valid petition is properly submitted within the designated period, the nominations shall be closed and the nominated slate of candidates shall be declared elected by the Board of the Chamber at the Annual Meeting, regardless of whether a Quorum is present at such meeting.

#### Senator Dan Roberts



I am State Senator Dan Roberts, and I am proud to represent District 15. As the State of Alabama continues to recover from the lasting effects of COVID-19, I want to highlight key legislation that is continuing to help ease the burden for all Alabamians.

Since the 2019 legislative session, I have sponsored several bills which deal with taxation of both individuals and businesses. When the federal stimulus monies began arriving, their prime intent was to assist those struggling to navigate the storm of COVID 19. These monies were intended to land in the pockets of hard-working Alabamians, and it was our job as the legislature to make sure that government did not

stand in the way.

The income tax exclusion on federal COVID-19 relief funds was a top priority for myself and my counterparts in the Alabama legislature. This legislation provided an income tax exemption for Alabamians who received stimulus money and aided Alabama-based businesses. Long before the pandemic, Alabama companies were at a competitive disadvantage. The Alabama Business Tax Competitiveness Act reduced the corporate income tax and incentivized companies that chose to remain or locate in Alabama, as well as, allowed Pass Thru Entities to file at the entity level.

An additional piece to helping families combat the financial effects of COVID-19 was the legislation that guaranteed Alabama families would not be penalized for benefitting from expanded tax credits included in the federal stimulus package. Without this critical piece of legislation, hard-working Alabama families would foot the bill on an extra \$87.7 million in state income taxes just by receiving the increased child tax credit, dependent care credit, and the earned income tax credit.

These critical bills moved swiftly through the legislature with bi-partisan support as it was our main objective to protect the citizens of Alabama.
