'UNITE HEARTS, MINDS AND SOULS ... CITIZENS RISE TOGETHER BY WORKING TOGETHER'

Mayor James shares his vision for 2021 for the City of West Palm Beach.

More than 1,000 guests viewed the 2021 State of the City Address with keynote speaker, Mayor Keith James, Esq., broadcasted live via YouTube. Mayor James and host Rick Reikenis, Chamber Board Chair, were recorded live in front of an intimate "live studio audience" at the Mandel Public Library Auditorium. Guests included city staff, Police Chief Frank Adderley, First Lady Mrs. Lorna James, former First Lady Carolyn Reikenis and sponsor representatives, who were masked and socially distanced.

Mayor James delivered the address with hope and conviction of strength, for all citizens of the City of West Palm Beach. "Citizens rise together, by working together ... a city's greatness is not measured by what we've already accomplished, a city's greatness is measured by what we still have to do together." He shared his vision and facts supporting the city's accomplishments in 2020, such as starting the "Mayor's Task Force for Racial & Ethnic Equality" with locally appointed leaders Michelle Diffenderfer, Esq. and Patrick Franklin, Mayor lames said, "No matter what race or background, our oai is that each citizen can realize

their dreams in our city." Mayor James also listed noteworthy accomplishments including balancing the 2020 budget of \$194 million with a \$10 million shortfall while keeping the millage rate the same and without any layoffs to any city fulltime employees – in spite of COVID related challenges. Additionally, in 2020 a goal was set for "300/3: 300 Workforce Housing Units to be built in 3 years." This has already been shattered, resulting in a new goal of

Smallridge is president and CEO of Palm Beach County's public/ private economic development agency, the Business Development Board of Palm Beach County (BDB) where she has worked for 32 years. She serves as the longest tenured

economic development president in the state of Florida and has a solid track record in facilitating some of the largest job creation projects for Palm Beach County. In 2013, then-Gov. Rick Scott awarded Smallridge with the Governor's Ambassador Medal recognizing her hard work in creating jobs in Palm Beach County.

In 2013 and 2019, she was featured on Fox News, CNBC and the NY Post touting the assets of Palm Beach County and her vision for "Wall Street South." Under her leadership, the BDB received numerous state and

national awards for its work in recruiting and expanding companies to Palm Beach County. Smallridge played a lead role in facilitating two of the world's largest bioscience organizations to the state: The Scripps Research Institute from San Diego and the Max Planck Society from Germany. Her aggressive style in landing relocations and expansions has led to big announcements of jobs for this county from companies such as United Technologies, Amazon, ADT, Pratt & Whitney, G4S, Fed Ex, Sikorsky Helicopters, Aldi, and TBC Corporation to name a few.

Chamber Board of Directors supports Governor DeSantis' funding of Visit Florida

The Board of Directors of the Chamber unanimously voted to support Governor Ron DeSantis' proposed funding of VISIT FLORIDA at \$50 million for Fiscal Year 2021-2022. This past year was the most challenging period in Florida's tourism history.
