Commerce of the Palm Beaches. Grady retired after 35 years of steady and thoughtful service.



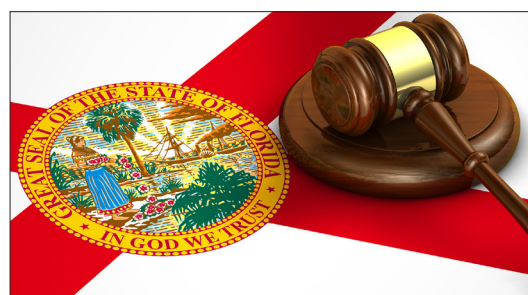

2021 LEGISLATIVE SESSION

Business Matters

The 2021 legislative session addressed several major issues facing the business community. SB 72 extended COVID-19 protections for businesses, schools, nonprofits, religious institutions and health care providers that make a "good faith effort" to follow government health guidelines. Under the bill, a plaintiff filing a lawsuit must prove with "clear and convincing evidence" that a defendant acted with "gross negligence." The new law also requires plaintiffs to obtain affidavits from physicians attesting defendants' acts or omissions caused damages, injuries, or death. In addition, the law raises the standard of proof in COVID-19 related lawsuits from the usual "preponderance of evidence" to "clear and convincing evidence" and requires cases be brought within one year of an alleged COVID-19-related problem.

SB 50 relating to sales and use tax would require online retailers to collect sales tax, which would bring an estimated \$1 billion in revenue. The "E-fairness" bill would create an enforcement mechanism on sales tax technically already owed on purchases Floridians make from out-of-state sellers. The plan would require out-of-state sellers to collect those taxes from consumers, as in a conventional purchase. This is not a new tax and is already owed under current law. It does shift the burden of collecting the taxes on remote sales from Florida consumers to out-



of-state retailers. The approximately \$1 billion in added annual state revenue collections will be deposited into the Unemployment Compensation (UC) Trust Fund, which has been decimated by job losses during the pandemic.

The legislature also passed a \$196 million tax package that would expand sales tax holidays while adding several new tax relief initiatives. In addition to the two sales tax holidays passed by both chambers, Florida will extend credits for hiring interns, cleaning contamination sites, and create an expanded property tax exemption for affordable housing.

Mark Wilson reports on 'State of the State'

Mark Wilson, CEO of the Florida Chamber of Commerce, shared real-time updates with participants at the Chamber's April Corporate Breakfast. Donald Burgess, new Chamber of Commerce of the Palm Beaches president and CEO, opened the program by welcoming Mark and Bill Bone, the Chamber's chair-elect and program host.

The theme of Wilson's presentation was "Uniting

Business for Good." He reported that some of the issues resolved in this year's legislative session included COVID liability protections (for employers), remote seller sales tax collections, and mitigation of the \$713 million unemployment tax increase.

Wilson also provided an update on the impact of COVID-19 on Florida and Palm Beach County, focusing largely on employment statistics.

There was also discussion on how the "Florida 2030 Blueprint" had been affected. For example, the original projection of 2 million additional jobs by 2030 had now been revised to 2.5 million to take into account jobs lost during the past 12 months.
