rental or repair of any of the qualifying items. Additionally, the sales tax holiday does not apply to sales in a theme park, entertainment complex, public lodging establishment or airport. Applicable items include coolers, power banks, flashlights, candles, lanterns, batteries, radios, and fuel containers.
