2022 Disaster Preparedness Sales Tax Holiday: May 28-June 10

South Floridians will enjoy a 14-day "disaster preparedness" sales tax holiday from May 28-June 10, for disaster preparedness supplies. Some examples of tax-free items include: flashlights and lanterns costing \$40 or less; radios costing \$50 or less; tarps costing \$100 or less; coolers costing \$60 or less; batteries costing \$50 or less; smoke detectors, fire extinguishers and carbon monoxide detectors costing \$70 or less; and generators costing \$1,000 or less. The holiday also includes a number of items related to the safe evacuation of household pets.
