The event was held at the Palm Beach County Convention Center where just under 700 guests gathered to hear the mayor's presentation. In declaring that the state of the city was good, Mayor James highlighted (among other things) the unprecedented surge in population over the past decade, the city's fiscal health, and community investments aimed at improving the quality of life for residents. The mayor


Kimberly Lea Sworn in As 2024 Chamber Chair
