- Vendors are required to have a product or experience for sale. Applications for booths intended for displaying information without items for sale will not be accepted.
- The event reserves the right to reject any application for vendor space or any item listed on a vendor application which is deemed unsafe or inappropriate for family viewing. The event reserves the right to inspect booths at any time during the festival to ensure compliance.
- The event holds the irrevocable right to assign booth locations.
- Vendors are responsible for cleaning their area, disposing of trash **inside** of the appropriate bins and returning the designated area to its original condition. Trash, including boxes, that does not fit in the trash cans must be taken with you.
- **Not cleaning up your area will result in losing your spot for next years event.**
- Set up information will be provided to vendors at time of confirmation.
- You are solely responsible for the reporting and payment of all sales/use tax applicable to your sales.
- **VENDOR FEES ARE NON-REFUNDABLE.**
