Disband: Gulfside Pavilion, Casino Beach Parking Lot

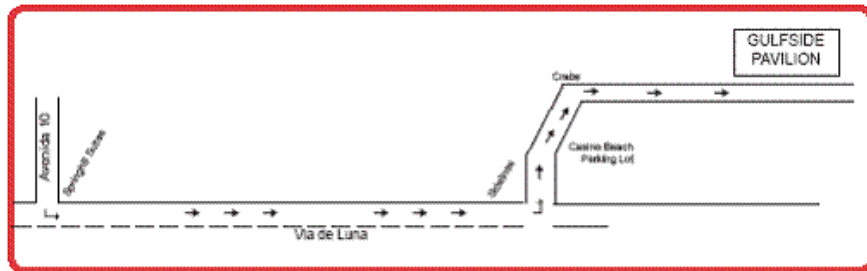

2. For safety, each large float should have designated walkers at each wheel.
3. All entries must be decorated including "tow" vehicles with costumed riders in Holiday Island Spirit.
4. Each entry is required to have Parade Throws. No Candy allowed. No used toys or stuffed animals.
4. No pick-up trucks unless they are being used as tow vehicles. Dancing groups may have support crew.
5. Check-in and line up begins at 12:30 p.m. Sunday, December 4th
6. Drivers must be licensed, responsible and sober.
7. Parade Marshal will turn away any entry which does not satisfy safety rules and guidelines.
