I. Consent Agenda

III. Reports

- A.  - 4. Provided the keynote speech at Palmer Rotary Club on April 9
 - 5. Set up GPCC's first two virtual coffee chats for members
 - 6. Participated in webinars
 - 7. Third Thursday meetup held on April 16, 2020
 - 8. Attended the City Council meeting. It was the current city manager's last meeting and the new city manager attended. Brad Hanson will be the interim city manager for the next two months.
 - 9. Reviewed upcoming speakers
 - 10. Drawing for Support Palmer coming up next week
 - 11. "Who Let the Girls Out" will be held on April 25 as a virtual event.
 - 12. The ED requested that new Cash Mob ideas be emailed or texted to her.

D. Events Committee Report

1. Sam provided the Events Committee Report and summarized the committee's discussion of GPCC's summer events. Friday Fling's start will be

postponed to after Colony Days' start. GPCC will consider possibly extending the Friday Fling season depending on the weather. Kalea and Randi called all vendors to inform them of the change.

- A. Cleanup Day will be held on the second Saturday in May and is a collaborative event between the City of Palmer and GPCC. Chamber sponsors the community barbecue on Saturday, May 9, and the bike giveaway. The barbecue is cancelled but the bike giveaway will be held with specific modifications to ensure the safety and health of participants.
- B. Palmer Bingo: Ailis discussed the new Palmer Bingo idea with the board. It was moved and approved to fund the \$100 gift card for the bingo prizes. There was a discussion regarding ways to encourage local spending of the gift cards. It was also discussed how best to prove the actions included on the bingo card, including selfies, screenshots, etc.
- C. Executive Session: The Executive Director Annual Review discussion was held while ED was not present. It was moved and approved to develop a structured raise and bonus system with clear criteria. Rob will form a committee to develop the criteria.
- D. Economic Impact Survey: The board and ED discussed the dissemination of an economic impact survey to assess the specific needs of the GPCC membership. It was moved and approved to distribute the survey and collect results.
- E. Letter of Support for Mat-Su Convention and Visitors Bureau: The Mat-Su CVB utilizes funds from the Mat-Su Borough bed tax to reinject those monies into positive tourism development projects in the Valley. A letter of support from GPCC was discussed by the board and ED. It was moved and approved to write a letter of support for the Mat-Su CVB on this issue.
