



## Friday Fling Application [Non-Profit & Community Outreach Booth]

---

### **Overview and Application**

Friday Fling will provide weekly opportunities for Non-Profit Organizations [NPOs] to host a booth for outreach and fundraising purposes. Please review the following regulations on NPO participation:

1. Non-Profit and community outreach booths will be assigned at the discretion of the Market Coordinator, and should have reservations confirmed prior to market season to ensure inclusion in marketing materials and event schedules. One booth space [P19 on Friday Fling Map] will be provided to host a weekly rotation of NPOs.
2. Booking priority will be given to NPOs with a strong membership-base or community involvement in Palmer and the Mat-Su Valley, and those with educational outreach related to sustainability, agriculture, community, and health.
3. Friday Fling will provide a 10' x 10' booth space. Participants must provide their own tent, chairs, booth, displays, and garbage disposal.
4. Fundraising efforts [such as raffle tickets, apparel, and the sale of baked goods] require approval from the Market Coordinator. Items offered in fundraiser must not compete with other Vendor sales, and should match the market ethic of healthy, locally-grown/handmade goods and services. Additionally, all items must be in accordance with the health code.
5. NPOs may not attend more than once per season without express approval from the Market Coordinator.
6. NPOs are required to have current 501[c][3] tax-exempt status and may only promote that which is related to that NPO, unless NPO has approval from the Market Coordinator.
7. NPOs may not promote or include any materials for partisan or political groups.
8. Please review the Friday Fling Handbook for regulations on setup, breakdown, etiquette, and other applicable rules
