I, hereby apply for Non-Designated REALTOR® Membership in the Williamson County Association of REALTORS® and enclose my payment of fees. In the event my application is approved, I agree as a condition to membership to complete the New Member Orientation Course and the Code of Ethics Class of the National Association of REALTORS®. Failure to satisfy this requirement within 120 days of the date of application (or, alternatively, the date that provisional membership was granted), will result in denial of the membership application or termination of provisional membership and fees will need to be repaid. I will abide by the Constitutions and Bylaws and Rules and Regulations of the Association, State and National Association, and if a REALTOR® member, will abide by the Code of Ethics of the NATIONAL ASSOCIATION OF REALTORS®. I further agree that my act of paying dues shall be evidence of my initial and continuing commitment to abide by the aforementioned Code of Ethics, Constitutions, Bylaws and duty to arbitrate, all as from time to time amended. Finally, I consent that and authorize the Association, through its Staff and/or Board of Directors or otherwise, to invite and receive information and comment about me from any member or other person, and I agree that any information and comment furnished to the Association by any member or other person in response to any such invitation shall be conclusively deemed to be privileged and not form the basis of any action by me for slander, libel or defamation of character.

I understand dues payments are not refundable. Your dues include a TAR Legal Fund assessment of \$5 and an Issues Mobilization Fund assessment of \$5. The Issues Mobilization Fund assessment is not deductible for income tax purposes. \$5 of your dues is for a subscription to Texas REALTOR® Magazine. \$6 of your dues is for a subscription to NAR's REALTOR® magazine. \$35 of your dues includes an assessment by NAR for all REALTORS® for a public awareness campaign that includes TV ads highlighting the value a REALTOR® brings to a transaction and qualifies as deductible dues. Investments are not deductible for Federal income tax purposes. Investments to the Texas Association of REALTORS® Political Action Committee (TREPAC), the Texas Association of REALTORS® Federal Political Action Committee (TAR FedPac), The REALTORS® Political Action Committee (RPAC) are voluntary and may be used for political purposes. The amount indicated is merely a guideline, and you may invest more or less than the suggested amount. The Association will not favor or disadvantage anyone by reason of the amount of their investment, and you may refuse to invest without reprisal by the Association. TREPAC initially receives each investment, and a percentage of no more than 30% is transmitted to RPAC via TAR FedPAC to meet TREPAC's RPAC annual quota. RPAC supports Federal candidates with those investments which are charged against your limits under 52 U.S.C. §30116. The percentage forwarded to national RPAC each month may be obtained by contacting the TAR FedPAC administrator at 800-873-9155. By making payment, you acknowledge the membership duties to which you agreed when you became a member, including your duty to arbitrate disputes as provided in NAR's Code of Ethics and the bylaws of WCREALTORS.

Note: Applicant acknowledges that if accepted as a member and he/she subsequently resigns or is expelled from membership in the Association with an ethics or arbitration request pending, the Board of Directors may condition renewal of membership upon the applicant's verification that he/she will submit to the pending ethics or arbitration proceeding and will abide by the decision of the Hearing Panel; or if applicant resigns or is expelled from membership without having complied with an award in arbitration, the Board of Directors may condition renewal of membership upon his/her payment of the award, plus any costs that have previously been established as due and payable, in relation thereto, provided that the award and such costs have not, in the interim, been otherwise satisfied.
