- Working with ALEDA on the new Small Business Relief Grant Funding Program which ended Jan.

- o Working with the 3 new Commissioners that came on board.

CVB (Holly Karsjens):

- o Big Freeze Feb. 12 & 13 with medallion hunt, scavenger hunt, retail event, hockey and fishing tournaments.
- o Main Street Program looking for new Board Member.
- o Working on 2021 events with food trucks and music.
- o Continue to promote takeout from restaurants and shop small to help our small businesses.

ALEDA (Phillip Johnson):

- December 2020 Chamber Financial Reports were presented. No questions or comments. Kevin Miland made a motion to approve the December financials. Seconded by Jeff Woodside. Motion carried.
- O Andy Bernau with Hill, Benda, Skov & Bernau PA presented a Draft of the Year-End Financial Statement dated Sept. 2020. Discussion was held on the Ambassador Funds column which states \$5,804 in the account. Mike Funk made a motion to approve the transfer of the General Ambassador Funds of \$5,804 to the Chamber Funds (which is only a bookkeeping entry). Seconded by Kevin Miland. Motion carried. (Note: The change in board designation was \$5,804 and the other \$9,000 is a previous year adjustment for those two years of scholarships.)

Chamber Financial/Membership Updates:

- Shari reported on the checking account balance being over \$20,000 higher than it was in January of 2019. She has asked the bookkeeper but hasn't received an answer as to why such a huge difference. She will continue to look into it.
- Staff bonuses (from December). Shari did not receive a bonus because the bookkeeper told her the director does not receive one. Mike Funk asked that Mike Chandler contact Bookkeeping Cents to fulfill Shari's Christmas Bonus.
- New members and Ambassador visits will proceed to try and schedule (if businesses are comfortable).
- o 2021 Letter to Members Board received a draft of the letter. Should let Shari know if they have any changes; otherwise, letter is ready to go out with 2021 tab.
