The ROOKIE of the Year program has been designed to honor and recognize those NEW REALTOR® members who have contributed most to the advancement of the real estate profession and the community.

To qualify for the 2021 REALTOR® Rookie of the Year, an agent must have been in the business for less than two (2) years. Also, be established in the real estate business by dedication, determination, professional development, and participation in the Association.

The Board of Directors of PRAR requests your nomination for the 2021 Rookie of the Year. The individual selected will be honored at the Annual Installation Event on December 9, 2021.

This award is based upon an individual REALTOR® member's contribution not only to PRAR, but also to their fellow members, the real estate profession and to the community. All nominations must be received by November 15, 2021.

PURPOSE:

To recognize and award new REALTOR® members for effort and work expended in the interest of fellow REALTORS®.

To demonstrate to the public outstanding examples of the work done by REALTORS®.

To foster a spirit of competition and cooperation among those who are in a position to serve the objectives and needs of the local association, SCR and NAR.

ELIGIBILITY POINTS TO BE CONSIDERED:

1. Must be a REALTOR® member in good standing of the Piedmont Regional Association of REALTORS®.
2. Should have been a member of the Association for less than two (2) years.
3. Must hold a permanent sales license or appraiser's certification and working day to day in the field of real estate.
4. Should be active in civic or community affairs.
5. Must be a leader. Must have earned the respect of fellow REALTORS® by his/her actions in the day-to-day business of Real Estate as a true professional.
6. Must be honest, trustworthy, and display the highest degree of unquestionable integrity and moral character with Associates, clients and the public. Must adhere with strict compliance to the Code of Ethics.
7. Should have attended a minimum of one (1) quarterly meeting during year being considered.

INELIGIBILITY FACTORS TO BE CONSIDERED:

1. Members not in good standing with the Association.
2. Affiliate members.
3. Anyone who does not possess an Active real estate broker's license, permanent sales license or appraiser's certification.
4. Anyone who is not been an active member of the Piedmont Regional Association of REALTORS®
5. Anyone who has been a Member of the National Association of REALTORS® or Licensed Real Estate Agent for more than 2 years.
6. Current President of the Piedmont Regional Association of REALTORS®.
7. Current members of ROOKIE of the Year committee.
