## **PURPOSE:**

To demonstrate to the public and PRAR Members outstanding examples of the work done by AFFILIATES.

To foster a spirit of competition and cooperation among those who are in a position to serve the objectives and needs of the local association, SCR, NAR and our community.

## **ELIGIBILITY POINTS TO BE CONSIDERED:**

1. Must be an AFFILIATE member in good standing of the Piedmont Regional Association of REALTORS®.
2. Should have been a member of the Association for at least three (3) years.
3. Should be active in civic or community affairs.
4. Must be a leader. Must have earned the respect of PRAR REALTORS® by his/her actions in the day-to-day business of Real Estate as a true professional.
5. Must be honest, trustworthy, and display the highest degree of unquestionable integrity and moral character with Associates, clients and the public.
6. Should have attended a minimum of one (1) quarterly meeting during year being considered.

## **INELIGIBILITY FACTORS TO BE CONSIDERED:**

1. Members not in good standing with the Association.
2. REALTOR® members.
3. Anyone who possess an Active real estate broker's license, permanent sales license or appraiser's certification.
4. Anyone who has not been an active member of the Piedmont Regional Association of REALTORS® for three- (3) consecutive years.
5. Current President of the Piedmont Regional Association of REALTORS®.
6. Current members of REALTOR®/AFFILIATE of the Year committee.
